1. Communicating with your instructor:

3. Course Description

This course is designed to develop skills and understanding in the following areas: relations and functions, inequalities, algebraic expressions and equations (absolute value, polynomial, radical, rational), with a special emphasis on linear and quadratic expressions and equations. This course does not transfer.

4. Course Requirements

Homework Assignments (10%) - There is an assigned homework for each section to be completed online using MyLab Math through D2L Brightspace. Homework pertaining to sections covered each week will be due Sunday at 11:59pm unless otherwise stated (see course outline). I strongly recommend you create a schedule for yourself for the sections each week and stick to it, DO NOT WAIT UNTIL SUNDAY TO START THE ASSIGNMENTS. You have unlimited tries to get every question right. You should begin the assignments as soon as possible after the material is covered in class. Although the homework is online, you should write out your work and put it in your notebook so you can study from it later.

Quizzes (10%) and Exams (80%) - There are 4 quizzes, 4 chapter exams and a comprehensive final exam. All of the quizzes and exams are to be done online using MML. You can retake each quiz just once to improve your score; the higher score will be the one that counts. Tests must be completed within the given window. There is also a time limit to complete the test once you start. **There are no retakes on any of the exams.** Be sure to label and write out your work/solutions for all tests and quizzes in a neat and organized manner, *you may be asked to submit photos of your work for credit*. The work from these problems will also come in handy to review as you prepare for subsequent tests and the final exam.

5. Late Work, Make-Up, and Extra-Credit Policy

As a general rule, there are no make-up exams. Students must make every effort to complete the exam within the exam window. Extensions for exams will only be considered under extenuating circumstances. If you need to miss an exam, you must **petition the instructor prior to the end of exam window and have a legitimate reason.** If you do not reach out prior to the exam, an extension will not be granted. All missed chapter tests will be assigned a zero, and the zero(s) will be used to calculate final grade in course. The final exam may be used to replace the lowest test score if it benefits the student.

Due dates for homework WILL NOT be extended (see Course Outline for due dates). Homework worked after the due date will receive a 20% deduction on all problems worked after the due date. You'll be able to work on past due homework and quizzes until the corresponding exam date.

There is no extra credit for this course.
