Course Description: The application of common algebraic functions, including polynomial, exponential, logarithmic, and rational, to problems in business, economics, and the social sciences are addressed. The applications include mathematics of finance, including simple and compound interest and annuities; systems of linear equations; matrices; linear programming; and probability, including expected value.

Course requirements:

- **Homework: Homework** assignments will be given each week for every section covered in the course. Homework assignments will count as 15% of your final grade.
- **Quizzes:** Four quizzes will be given. Cumulatively, the quizzes will count as 10% of your final grade.
- **Unit Exams:** Four exams will be given, and you will be provided with a review to prepare for each exam. Each test will count as 15% of your grade.
- **Final Exam:** The comprehensive final exam will be given at the end of the course during Week 8. The final exam will count as 15% of your grade and will replace your lowest exam grade if it is higher.
- Required Technology: A TI-84 Plus graphing calculator is required for this course.

- o A TI-89 or higher or a TI-Nspire are **not permitted.** Internet capability is also required to gain access to course materials and online assignments via MyLab Math software.
- MyLab Math (MLM) contained within Brightspace is required for this class.
