**Required Textbook/Materials:** College Algebra, 5th edition by Beecher, Penna, Bittinger, from Pearson. E-Book via MyMathLab in Brightspace - D2L (**No Purchase Necessary**). We will be using MyMathLab for all assignments and some assessments.

**Course Description:** College Algebra is an in-depth study and applications of polynomial, rational, exponential, and logarithmic functions, and systems of equations using matrices.

**Course requirements:** **This is a hybrid class. Students will be required students to learn some of the material outside of class with the aid of videos which will be provided.**

**HW:** There will be a homework assignment for each section covered, whether in-class or outside of class.to be done online using MyMathLab.

**Quizzes:** There are four quizzes to be done online using MyMathlab. You can retake each quiz just once to improve your score; the higher score will be the one that counts. There may also be regular in-class quizzes. In-class quizzes cannot be made-up or retaken.

**Exams:** There will be four chapter-exams and a comprehensive final. At least one of the chapter exams will be online. Students are expected to turn in the work for the on-line test(s) during the next class period. Late work will not be accepted. The penalty for no work shown is 20% per problem. **There are no retakes on any of the exams. All due dates are on the course outline.**

**Determination of Course Grade/Detailed Grading Formula:** The course grade will be determined by the following formula:

$$10\% \text{ HWAverage} + 10\% \text{ Quiz Average} + 60\% \text{ Exam Average} + 20\% \text{ Final Exam} = \text{Final Average}$$
