You will need computer access to the internet to use MyMathLab. If you do not have a computer and/or dependable internet access, contact your professor immediately so that you may discuss any options that may be available to you through the college.

**Course Description:** : Topics include introductory treatments of sets and logic, financial mathematics, probability and statistics with appropriate applications. Number sense, proportional reasoning, estimation, technology, and communication will be embedded throughout the course.

**Course requirements:** Access to internet to work on Black board platform and Mymathlab.

**Determination of Course Grade/Detailed Grading Formula:**

**Discussion Forums:** Discussion forums will be assigned four times throughout the course to give students the opportunity to exchange and clarify ideas. Students are asked to answer one or more questions as thoroughly as possible, and then to comment on at least two of their classmates' responses to the questions.

**Homework Assignments on MyMathLab:** There is a homework assignment for each unit covered. These are listed on the course outline of this syllabus. Each day's homework assignments must be completed by 11:59 pm on the due date shown on both the course outline and on the list of assignments on MyMathLab.

**Quizzes on MyMathLab:** Six quizzes which relate to the student learning outcomes, will be done on MyMathLab. Like the homework assignments, the due dates are shown on both the course outline on this syllabus and on the assignment list on MyMathLab. Unlike the homework assignments, the quizzes must be taken in one sitting, they are timed, and the student gets only one attempt to answer each question. The quizzes may be retaken one time. The higher of the two grades will be used to determine the student's quiz average.

**Chapter Exams:** There are four exams which cover the chapters in the text book. The exams are taken on MyMathLab and are to be finished by the due dates shown on the course outline on this syllabus and on the course outline on MyMathLab.

The student has two hours to take each exam. Like the quizzes, the exams must be taken in one sitting, and the student gets only one attempt to answer each question. Exams may not be retaken.

**Comprehensive Final Exam:** The comprehensive final exam is taken on MyMathLab and must be finished by the due date shown on the course outline on this syllabus and on the assignment list on MyMathLab. The student has two hours to complete the final exam. The final exam must be taken in one sitting, and the student gets only one attempt to answer each question. The final exam may not be retaken.
