**Required Textbooks and Materials:**

The course will use electronic (e-text) versions of the text listed below. Use of the electronic texts will save money for the student, and not require the books to be carried to and from class. A flash drive or cloud storage is recommended but not required to save/access your work.

The inclusive access code will have access to the electronic (e- text) for Microsoft 365 2019 Office in Practice ISBN 978-1-260-07990-6. Inclusive means that you pay for the course if you decide to continue the course after census day.

**Textbook Purchasing Statement:**

A student attending College of the Mainland is not under any obligation to purchase a textbook from the college-affiliated bookstore. The same textbook may also be available from an independent retailer, including an online retailer.

**Course Description:**

Students study computer terminology, hardware, and software related to the business environment. The focus of this course is on business productivity software applications (Word, PowerPoint, Excel, and Access) and professional behavior in computing, including word processing (as needed), spreadsheets, databases, presentation graphics, and business- oriented utilization of the Internet.

**Course Requirements:**

This is a 16-week course. Course work will be completed by the student via the SIMnet internet tool on his/her own personal computers, or in the COM Computer Labs, where the computers are equipped with Microsoft Office 2019 and links to SIMnet.

All course work must be turned in as *MICROSOFT OFFICE 2019 documents* – no exceptions. Any student lacking the necessary Microsoft software can find it for download at the bottom of the COM homepage in the Microsoft Office link. Please note that while you may use a MAC for some applications, Microsoft does

NOT make a MAC equivalent for ACCESS. You will need to use a computer lab or a borrowed computer from the library or another source to complete these assignments.

All chapter (SIM Book) readings and skills training should be completed before starting any assignments, although this is not required. The reading and completion of the training self- assessments can be done concurrently. In Blackboard, complete the discussion questions and the class PowerPoint (details below). Students will see their SIMnet grades upon completion of assignments, but there may be a delay before these are reflected in Blackboard.

Course work will include reading of assigned chapters, completion of chapter hands-on training and self-assessment exercises, homework projects using the skills developed in that unit, a class presentation, and participation in discussions and other assigned activities. All course materials, assignments and tests will be accessed through SIMnet or in Blackboard. Scheduled due dates and point values are provided in the links in SIMnet and Blackboard.

Students will take end-of-chapter quizzes via SIMnet skills training and assessment system and Application Tests using the live Office application.

The Word, PowerPoint, and Excel application tests are very similar to the grader projects which are assigned for each chapter. A list of the skills that are being tested will be provided in Blackboard for each test and the Final Exam. The application tests will be completed using the instructions provided and with the actual Office application (not a simulation). The completed test file will then be submitted to SIMnet for automatic scoring. Each test is scored in percentage.

### **Determination of Course Grade/Detailed Grading Formula:**

The grading elements for the course are:

- 50% of Grade will be SIMnet Exams
- 30% will be SIMnet Projects
- 10% will be SimBooks and Lessons
- 5% will be discussion questions
- 5% is the class PowerPoint.

The Blackboard gradebook will have all scores as they are accumulated throughout the semester (all individual SIMnet scores are copied to Blackboard so the student can see his/her progress and all scores in the preferred location). The final grade and individual scores are retained in Blackboard as part of the students' official records. It is the student's responsibility to use these tools to be aware of the due dates and requirements for all assignments and tests.

## **Late Work & Extra Credit/Bonus Policies:**

To the extent possible (given limitations by publisher and linking sites), late work will be accepted with a 20% penalty applied. Group Projects will NOT be accepted late under any circumstances. Late work that requires manual grading (Bb assignments with a rubric, generally) will be accepted up until the Sunday prior to the last day of class. Late work that is auto-graded will be accepted up until the day prior to the last day of class.

If you have a personal or emergency situation, please contact me as soon as practical (in advance when possible) and I will do my best to work with you in a fair and equitable manner. Supporting documentation may be requested.

## **Collaborative Work**

The nature of this class requires some collaboration and communication with your peers via discussions and other activities. Quizzes, training/exam assignments, and projects must be done individually. While students can consult with each other about strategies and resources, you must complete all work on the assignments yourself.

For this class, it is permissible to assist classmates if you can meet, either in person or via the communication tools (discussion topics, chat). Each person **MUST**, however, develop his/her own solutions to the assignments and projects. In other words, students may not "work together" to complete a joint graded assignment. Such collaboration constitutes cheating. There are no team assignments in this class. A student may not use or copy (by any means) another's work (or any portions of it) and represent it as his/her own. The SIMnet tool can detect whenever a grader project contains content from another student and will flag this as a potential integrity violation.

These will be used to determine the nature of the problem. Many problems within Blackboard are based on high usage (too many people online at the same time). Problems with SIMnet will be announced on the log in page, so be sure to note any issues with their server and try to plan around any outages.

You are expected to have intermediate or higher-level skills at file management: the ability to create folders, move and rename folders and files, identify type of file by its 3-letter file- extension, attach files to emails, and download plug-ins or data files required for the course.

Updated virus scanning software for all files you send and receive such as McAfee Antivirus, Norton Internet Security, etc. is recommended. Be sure to add <http://de.com.edu> to your virus software's trusted sites. Spyware, parasites, and other deceptive software can cause problems when using Blackboard or other websites. Blackboard recommends that you check for, then uninstall or temporarily disable these types of software to eliminate problems when accessing Blackboard. ## **Computer Software Ability:**

Basic computer skills for the course require knowledge of the following:

- E-mail (sending, opening, replying, and uploading/saving attachments)
- Web browsing (navigating, searching, downloading files and browser plug-ins)
- Using the mouse and/or keyboard to activate commands and functions, including drag and drop features, text highlighting, and right clicking to select command options.
- Blackboard navigation and how to submit attachments and take quizzes

These skills will be greatly improved in ability and speed after completion of the course.

## **MAC versus PC:**

Please note that some assignments will NOT be able to be completed on a MAC. Microsoft does NOT make any version of Access available for MAC operating systems. Therefore, you will need to find an alternative device on which to complete the assignments.
