Course Description: Government 2306 is an introduction to politics and government in the state of Texas. The purpose of this introduction is to acquire knowledge of the basic principles and practices of state politics.

This semester we will study federalism and inter-governmental relations, the political culture of Texas, the origin and development of the Texas Constitution, the structure and powers of state government, political participation, the election process, and issues in public policy.

This introductory course will also attempt to understand some of the basic questions and problems encountered by political science and political philosophy. For an introduction to these questions, we will read an essay "The Five Conceptions of American Liberty" by Carl Eric Scott and explore some the basic concepts of political science.

Course Requirements

Course Exams: There are three (3) Unit Exams. Each exam will cover the required textbook chapter readings, lecture notes, and additional readings. The exams will consist of multiple-choice questions.

Short Papers: Throughout the course you will complete four (4) short papers (2 pages at a minimum) over a selected topic. Additional information on grading rubric, submission, format, citations, etc. will be provided in the assignment file. Submit in class.

Research Paper: Write a Position Paper on a current public policy controversy in the Texas (e.g., Should marijuana be legalized in Texas?; Should Texas legalize casino gambling?; Should Texas prohibit “sanctuary cities?”; Should Texas prohibit the teaching of “Critical Race Theory” in public primary and secondary schools?; Should Texas reverse its voting laws requiring a government issue photo ID and prohibiting mail in ballots?; Should Texas introduce Covid vaccine mandates?; etc.).

Make sure that your paper is on a topic that is statewide in scope, and not an issue that pertains to the entire nation.

Write a paper taking a position (yes or no) on a current public policy controversy. What is the issue? Explain in detail. What is the policy proposal (e.g., which law? which action? which program? which institution? etc.) you are in favor of or against? Explain in detail.

Conduct research on the topic, citing at least three sources from credible and reliable publications, web sites, journals, books, etc. Formulate an argument based on evidence in defense of the position you are taking. Also, respond to the most common objections to this position. Explain how this position impacts the issues of personal responsibility and social responsibility.

The paper should be 1000 words (approximately 5 pages), double-spaced, with one-inch margins, and a 12-point font. Use a standard style for references, citations, and the list of sources (e.g., MLA, Chicago, or APA). Submit in class.

Emergency Assignment: If for any reason the college closes, continue to work on the assignments spelled out in your syllabus and/or refer to Blackboard for Emergency Closing Assignments and further instructions.
