# Required Textbook: Lone Star Politics (7<sup>th</sup> or 8<sup>th</sup> Ed.), Ken Collier et al, Sage (CQ) Press. 2022, 2024.

## **Course Description:**

Government 2306 is an introduction to politics and government of Texas. The purpose of this introduction is to acquire knowledge of basic principles and practices of the state government. This semester we will study the origins and development of the state government, the origins and development of the state and federal constitutions; the idea of separation of powers and checks and balances; the idea of federalism; the institutions of legislature, the Governor, the Plural Executive, the public administration, and the Judiciary; civil rights and civil liberties; public opinion, political parties, and elections; and issues of political science and public policy.

### **Course requirements:**

Tests: There are three covering the required readings and lectures from each unit. A bonus of up to 10 points for each test is described below. Each test counts 25% of the final grade.

Paper: Write one three to five page essay on any topic in Texas politics, government or policy. Write a Position Paper on a current public policy controversy in the state of Texas Take a position. Conduct research on the topic, citing three sources from credible and reliable publications, web sites, journals, books, etc. Formulate an argument and respond to the objections to this position. The paper should include a social and professional responsibility perspective. The paper counts 25% of the grade.
