Course Description: A survey of the social, political, economic, cultural, and intellectual history of the United States from the pre-Columbian era to the Civil War/Reconstruction period. United States History I includes the study of pre-Columbian, colonial, revolutionary, early national, slavery and sectionalism, and the Civil War and Reconstruction eras. Themes that may be addressed in United States History I include American settlement and diversity, American culture, religion, civil and human rights, technological change, economic change, immigration and migration, and creation of the federal government

Course requirements:

Exams: There will be **four exams** during the semester with a value of **100** points each, 60 points for a Multiple-Choice portion, 40 points for the two short answer portions of the test. Exam material will be drawn from quizzes, assigned readings, D2L/Brightspace assignments and all class activities. Students should pay particular attention to terms in the study guides and quizzes, which will be available on D2L at the beginning of the module. Each exam may consist of multiple-choice questions, short answers, and map questions.

Core Objective: Critical Thinking

Writing Portion Exams: There will be **four writing portion exams** during the semester, these are in addition to the multiple-choice exams you will take in class. Writing Portion Exams will be available from the beginning of a Module, so you will have several weeks to work on these essays. The instructions for the writing portion will be on D2L.

Assessment Quizzes: In addition to the four exams, there will be at least **10** quizzes to assess your progress between major exams. We will have more than 10 quizzes, for example, if we have 15 quizzes, we will drop the lowest 5 quizzes at the end of the semester. Quizzes will count for 100 points (10 points for each quiz). Quizzes will be in D2L. **Like exams, quizzes cannot be made up.** Missed quizzes receive a grade of zero. Quiz dates are not listed on the syllabus as quizzes will be released when we finish the topic. In order to take the quiz in D2L you must be present in class when we cover the topic and if there is any online component to complete, you must complete that before your quiz will release. Quiz dates will be announced in class and available on D2L as we will need to finish a topic before a quiz is released.

Quizzes address the following Core Objective: Critical Thinking.

Introduction Discussion Board: Students will post an introductory discussion board video. Please follow the instructions in D2L for your video. If you follow the instructions, we will not have to download your video to view. In your video you will: Start by introducing yourself. Your name, things that you like to do outside of school. What is your expectation in 5 years, where you plan to be, and what do you plan to be doing? Also, if you could have dinner with anyone from History, who would it be and why? Respond to two other posters. Please review the Rubric so you know how this discussion will be graded.

Discussion Board: There will be weekly Discussion Board entries. Initial posts need to be at least 100 words and have a thorough discussion of the topic question presented. Initial posts will be due on Friday and two responses will be due on Sunday. Students must respond to at least two other posters for full credit. Each discussion board post is worth 10 points. Please review the discussion board etiquette in D2L Brightspace. **Initial posts are always due on Friday's, two responses are due by Sunday of each week.**

Research Paper Proposal: After you have your topic approved on the discussion board, you will need to submit a proposal. Your proposal should include your thesis statement and at least 3 of the 5 sources you will use for your paper. The topic you pick will be used for your research paper and your oral presentation. Instructions are in D2L.

Research Paper: Each student will write a 5-page research paper on a topic in US History from 1492-1877. This paper should be in a research paper format and **NO LESS** than 5 pages, a works cited page should be included. Follow MLA formatting guidelines, including citations and a works cited page. Paper must be double spaced Times New Roman font, 12 pt. Please review rubric for grading criteria. Before you write your paper, post your topic on the appropriate discussion board. This is to make sure you choose a topic that falls into the scope of this class. If you do not post in the discussion board and get your topic approved, you risk receiving a zero for

the paper. You must use at least 5 sources (**no textbooks of any kind**). You will also be **required** to use the COM Tutoring center to receive feedback for your paper. Please make sure you follow all writing information that we discuss in class.

Oral Presentations: Each student will create an oral presentation over the topic that you wrote your research paper on. You will not read the paper but give a presentation telling us what you learned about the subject. Students will record their video in D2L, please follow the instructions in D2L, so that we do not have to download your video. The presentations should be 3-5 minutes long.

Responsibility Paper: Students will write a two-page typed paper on the Social and Personal Responsibility of a person or event that falls between 1492-1877. This topic must be U.S. History. . The student must include a paragraph in their paper discussing the social and personal responsibility of the individuals involved. Students will use **primary and secondary** sources for their paper. You must include a works cited page. Before you write your paper, post your topic on the appropriate discussion board. This is to make sure you choose a topic that falls into the scope of this class. If you do not post in the discussion board and get your topic approved, you risk receiving a zero for the paper. You will also be required to use the COM Tutoring Center to receive feedback for your paper.

Example: Harriet Tubman's decision to help runaway slaves, what are the consequences of her actions? What personal responsibility does she have and how does it influence those around her? What social responsibility does she have and how does it influence those around her?
Covers: Critical Thinking, Social Responsibility, Personal Responsibility, Communication

All Paper Requirements: Points will be taken for incorrect formats.

- Spelling and capitalization need to be correct
- All papers must have a title page, be typed, double spaced with a 12-pt. font
- All pages must have appropriately sized margins.
- All papers must contain information detailed in the procedure section of these guidelines

Turnitin: All papers will be submitted to Turnitin. Please check your similarity report, this flags plagiarism. Also, Turnitin now checks to see if your paper was written by Artificial Intelligence, you will not see this percentage, but your instructor will. Any percentage of Artificial Intelligence usage will result in a zero for your paper. Do not use Grammarly or any other online helpers to help you write your paper, it will show up as Artificial Intelligence. If you need help with papers use the COM Tutoring Center.

No "Recycled Assignments for Course Credit: You may not re-submit an essay or discussion post (or portions thereof) that you did in another course for credit in this course, including

material from one of my classes in an earlier semester. Therefore, even if you have done an assignment before in another class, you must do it from scratch this semester.

Grades: Students should be reviewing their grades and feedback frequently.

Feedback: In order to improve your writing, you should be reviewing feedback. When you upload your paper, you should review your similarity percentage and fix your papers.

There are no redo's on assignments.

I will substitute your lowest exam grade for one missed exam (this **DOES NOT** mean I drop a grade). If you miss more than one exam those grades will be zero.

Make-Up Policy: There will be NO makeup tests or quizzes given. You are given dates for exams in advance. Please make every effort to be in class on that day as I will not give you any make-up. Research and Responsibility papers are available for several weeks, you should be working on them and not wait until the last minute. I will not give extensions on any papers as they are available for weeks.

Late work will not be accepted. I do not give extensions on assignments. Please do not email me assignments. **Due dates/time are Central Standard Time.**

Please be aware going on a trip/vacation does not warrant getting extra time to complete assignments.

If you have issues with an assignment you need to see me **BEFORE** the assignment is due. I cannot help you if you contact me after the assignment is due.

If you have issues with the grade on an assignment **DO NOT** wait until the end of the semester to say something. I will not go all the way back to look at those assignments.

Internet Access: You are responsible for obtaining access to the Internet to get your assignments done on time. "My computer broke," "My Internet was down," or "I forgot I was in a different time zone" are not excuses for failing to complete an assignment on time. Another good idea is to e-mail assignments to yourself as file attachments so you can access them from other computers.
