Course Description:

This course is an introduction to the fundamental concepts of financial accounting as prescribed by the U.S. generally accepted accounting principles (GAAP) as applied to transactions and events that affect business organizations. Students will examine the procedures and systems to accumulate, analyze, measure, and record financial transactions. Students will use recorded financial information to prepare a balance sheet, income statement, statement of cash flows, and statement of shareholders' equity to communicate the business entity's results of operations and financial position to users of financial information who are external to the company. Students will study the nature of assets, liabilities, and owners' equity while learning to use reported financial information for purposes of making decisions about the company. Students will be exposed to International Financial Reporting Standards (IFRS).

Course requirements:

1. The student will correctly respond in writing to the total of 4 objectives, and quantitative - problem exams given throughout the semester. The exams will be taken online without the use of books or class notes unless otherwise specified. The student's response will demonstrate his/her proficiency in the course material. The exams will address **Core Objectives: Empirical and Quantitative Skills and Critical Thinking Skills.**

- 2. The student will complete almost 100% of the problem assignments using the Harris Learning Solutions (HLS)/Lyryx (formerly named by this name) platform. These assignments are due at the beginning of the class on the date assigned. Students will complete **one discussion board item on D2L Brightspace**.
- 3. Harris Learning Solutions (HLS)/Lyryx: The student will complete 10 labs/homework and cases utilizing HLS/Lyryx online platform. The student will analyze the case facts given and design an algorithm (or complete a template) to produce the information necessary to satisfy the accounting application. These can be completed in the Tutoring center or at home. The instructor will issue these assignments on a weekly basis. The directions to complete the assignments will be provided by the instructor (and grading will be done in accordance with the instructor's specifications).
 - NOTE: No passing grade can be awarded in the course if the student fails to complete the minimum number of problems/labs/homework assignments.

1. The final grade will be based on the quizzes given during the semester and completion of the minimum number of Lab and homework assignments.

Late work, Make-Up, Study habits, Preparation for class and Extra Credit Policy:

1. As a general policy, no make-up exams or quizzes will be given since the student is provided with an adequate window of opportunity to complete all course work.

- 2. Since exams and labs are all available from the first day of class, it is the responsibility of the student to plan his/her time wisely and complete the assignments a day before the last day to submit for grading so that any technical glitches or last-minute emergencies will be averted. Only under extenuating circumstances such as a death of a family member or hospitalization and at the specific request of the student will any consideration be given to extend any deadline.
- **3.** This course is taught in hybrid format. This means that you must attend class for 3 hours per week and devote 3 more hours reading the chapter, attempting the reinforcement questions that would have been covered in a 100% face to face format. Note: This is not a 3 hour per week class. Students who cannot devote a minimum of 8 hours week to this course should consider taking the class in a semester that allows for this time commitment.

Attendance Policy:

Roll will be taken in each class period (only if this class is scheduled to be face to face or in hybrid format) and 100% attendance is expected. Class begins promptly. You are expected to be in class by 8AM on both class days. If you are taking this class online, you are expected to log into D2L Brightspace at least 4 times a week. Those students,

who in the instructor's judgment miss enough class to prevent successful completion of this course, may be withdrawn from the course. Otherwise, as stated in the College catalog, it will be the responsibility of the students themselves to withdraw from the course prior to the **W-Day April 30th** deadline if they elect to do so, to assure a grade of "W" rather than a grade of "F".
