**Course Description:** Class instruction in fundamental guitar playing, including technique, musicreading, fretboard theory, melodic and harmonic realizations. Designed for the guitar student with little or no prior experience. Students should have an instrument: electric or acoustical guitar acceptable. Class guitar is recommended prior to individual guitar instruction.

Course requirements: Weekly meetings, 2 exams
