# **Course Description**

This course develops basic Spanish language skills in listening, speaking, reading, and writing within a cultural framework. Students will acquire the vocabulary and grammatical structures necessary to communicate and comprehend at the beginner level.

• A detailed course study plan is posted in each chapter folder in Brightspace. These schedules will give you a daily plan to approach the study of the course broken down by individual topics and homework assignments. All work is due at the end of the chapter. However, after week one, if many of you are not pacing yourselves and creating a timeline to finish the chapter on a weekly basis, I will change this schedule and assignments will be due on a daily or semi-daily basis instead of once per week. (the daily approach will help you to stay on task and it is this is the best way to learn a language: working in small increments but on a daily basis) I will talk more about this in class.
