**Course Description:** A systematic evaluation of classical and/or contemporary ethical theories concerning the good life, human conduct in society, morals and standards of value. Prerequisites: ENGL 1301 with a grade of "C" or better.

**Course requirements :** There will be nine grades----5 quizzes and 4 tests

**Determination of Course Grade:** All nine grades are weighted the same. The lowest quiz grade and the lowest test grade will be dropped. The final course grade will be determined by averaging the remaining 7 grades. There are no make-ups in this class, and no test nor quiz may be taken early or late.

**Course outline :** The course will begin with an introduction to moral philosophy that will include a consideration of metaethics and bioethics. We will then take up major moral theories and current problems in moral philosophy in a recursive order that will unfold the larger philosophical project in a historical context.

**Attendance Policy:** Students are expected to attend all classes And are responsible for anything that is missed. Attendance is NOT a part of the student's grade.

**Withdrawal Policy:** Students may withdraw from this course for any reason prior to the last eligible day for a "W" grade. Before withdrawing students should speak with the instructor and consult an advisor. Students are only permitted to withdraw six times during their college career by State law. The last day to withdraw is April 25th.
