#### **Course Description:**

# NURSING CARE OF THE CHILDBEARING AND CHILDREARING FAMILY CLINICAL (LECTURE 0, CLIN 6). CREDIT 2. WECM.

Study of the concepts related to the provision of nursing care for childbearing and childrearing families. Application of systematic problem-solving processes and critical thinking skills, including a focus on the childbearing family during the perinatal periods and the childrearing family from birth to adolescence; and competency in knowledge, judgment, skill, and professional values within a legal/ethical framework.

# Course requirements (may include any or all of the following):

1. **Medication Exam** - Assesses proficiency in dosage calculations. Students will score 90%. If 90% is not achieved, the student will receive remediation and additional attempts. Students may not pass medications until they have successfully completed the Medication Administration Exam with 90% or more. For full requirements please see Medication Administration Policy in the Nursing Student Handbook.

- 2. **Health Promotion Group Presentation** Assesses the understanding and application of appropriate patient/family teaching on an assigned Pediatric or OB topic. The topic will be researched by the group and presented at the end of the semester.
- 3. **Weekly Documentation** Assesses the understanding of care that identifies patient goals/outcomes, nursing interventions. Assesses the ability to understand, collaborate and communicate in a timely manner with the healthcare team to plan, deliver, and evaluate patient-centered care in the inpatient setting.
- 4. **Shadow Health-** Virtual patient assessments for a variety of pediatric and maternity disease processes. The grade will be determined by the DCE score.
- 5. **Simulation Lab** A hands-on learning environment to continue preparation for the nursing role.
- 6. **School Nurse-** public or private school setting.
- 7. Clinical Evaluation Assesses clinical competency. (Mid-term and Final)
- 8. **Concept Map** Assesses the understanding of the disease process to allow you to provide better care for your patient goals/outcomes, nursing interventions. Assesses the ability to understand what is happening to your patient to allow you to better collaborate and communicate with the healthcare team to plan, deliver, and evaluate patient-centered care in the inpatient setting.

#### Clinical Guidelines

# **Guidelines for Clinical Experience**

- 1. Mandatory facility "Orientation" date and time is noted on the course calendar. Additional instructions regarding directions to the facility, parking fees, etc. will be given in class.
- 2. Dress code includes wearing scrubs at all clinical facilities. Students who are dismissed from clinical, lab, class or a COM-sponsored event due to non-

- compliance with uniform or hygiene standards will not be provided make-up opportunities for any missed assignments or clinical hours. See Uniform Requirements Policy in the Nursing Student Handbook.
- 3. Wear your school's name badge at all times in the clinical setting. You may be required to get an additional photo and badge at some facilities. Failure to bring/wear the COM ID Badge to clinical and/or the clinical site ID badge will result in the student being sent home for the day from the clinical site. See Uniform Requirements Policy in the Nursing Student Handbook.

# **Student Activities during the Clinical Day**

During a typical clinical day, the student will:

- 1. Arrive at the clinical facility at the designated time, dressed appropriately, and without any dangling jewelry from the ears, neck, or wrists (safety issue), and with no excessive cosmetics or perfume, and avoiding any provocative dress or behavior that would call undue attention to oneself.
- 2. Meet with your clinical instructor at the time and place for pre-conference.
- 3. Go to your unit and put your books, etc. in the designated place for students. Do not bring anything like your books or backpack, etc., out into patient care areas. Many units do not have an area for students, so do not bring anything that is not essential for your clinical day.
- 4. Do not bring valuables to clinical, e.g., large amounts of money or credit cards or expensive jewelry (leave them locked in your car if brought unintentionally).
- 5. Meet with the charge nurse for the shift report/staff assignment.
- 6. Collaborate with your nurse preceptor for lunch (30 minutes). Do not leave the facility.
- 7. Consult with your clinical instructor freely.
- 8. Arrive and participate in post conference at the designated time and place.

#### **Guidelines for Medication Administration**

Pharmacology is an important aspect of the clinical experience. You will discuss your patient's medications daily with the clinical instructor. You will be responsible for knowing about all your patient's medications (both scheduled & prn), classification, action, indications for use, dosage, time, route, side effects, nursing implications, and target symptoms for your client. Monitoring patients for medication effectiveness is also an important aspect of the nurse's role.

# **Guidelines for Charting**

You may read the patients' chart, but do not make copies of anything in the patient record without permission from the charge nurse and your instructor. You will be expected to report only pertinent data from any medical and/or lab tests for Concept Maps etc., so it should not be necessary to copy any forms from a patient chart.

- Assessment should occur early and be completed with the bedside nurse preceptor and/or faculty.
- Medications may be given with the nurse preceptor and/or faculty as allowed after the student completes the math competency.
- Procedures that the student has already proven competence may be performed

with the bedside nurse preceptor and/or faculty.

• All SBARs should be problem based unless specifically requested in rubric.

Clinical Facilities Inpatient facilities include Texas Children's Hospital, HCA Clear Lake, and UTMB Galveston campus. All dates are listed in the *clinical grid for each student* but are subject to change with notice from the instructor.

# **Clinical Conferences**

Students are expected to attend any pre- and post-conferences at the time and place designated by the clinical instructor. Post-conference learning activities are at the discretion of the clinical instructor, and all students are expected to comply and complete the requested assignments.

# Non-permissible Nursing Skills

Skills that will not be performed throughout nursing school at COM are:

- Administration of blood or blood products
- IV push medications
- Care of a patient with an airborne illness requiring the use of an N95 face mask
- Titration or initiation of Pitocin or Magnesium Sulfate infusions

Performance of these skills by a nursing student is considered unsafe and can result in dismissal from the program.
