**Required Textbook/Materials:** We will utilize OpenStax free online textbook. The link has been provided. You can view this textbook on the web or download a PDF format. You have the option to purchase a hard copy if you wish. <https://openstax.org/details/books/us-history>

**Course Description:** A survey of the social, political, economic, cultural, and intellectual history of the United States from the pre-Columbian era to the Civil War/Reconstruction period. United States History I includes the study of pre-Columbian, colonial, revolutionary, early national, slavery and sectionalism, and the Civil War/Reconstruction eras. Themes that may be addressed in United States History I include American settlement and diversity, American culture, religion, civil and human rights, technological change, economic change, immigration and migration, and creation of the federal government.

**Course requirements:**

**Writing Assignments-** After each week's reading, students will select an outside primary or secondary source that relates to it. In a One Drive document, the student will answer three questions about their selected source. The purpose of the One Drive format is so that the instructor can provide feedback on a regular basis so that the student may revise the document before the final turn in. The final products will be turned in by providing a link to the document in Brightspace. Further instructions will be available on Brightspace.

**Discussions-** Each week students will be assigned a reading to supplement the lecture. One day of each week we will conduct a classroom discussion of the reading. To receive full credit a student must contribute to the discussion 5 times. To receive credit students must make a significant contribution to the discussion, simple closed ended answers like "I agree" or "yes/no" will not count. Students will receive punch cards to keep track of their contributions.

**Activity Participation-** Each week we will participate in activities designed to supplement the week's lecture. Students are expected to participate in the week's activity.

**Activity Reflection-** Each week, students will create a One Drive document entry reflecting on their participation in that week’s activity. The reflection will include student experience in the activity and how it connects and expands on the lecture.

**Exam-** On the week 5 of the course, students will have a 20-question exam. The exam will be multiple choice questions based on the key terms from each lecture.
