## **Required Textbook/Materials:**

Students are required to additionally have pencils and music staff paper at all class meetings. No other materials to be supplied by the student will be needed. Sight-reading materials will be supplied by the instructor, as will ear-training resources. Students are recommended (not required) to use musictheory net for ear training practice in conjunction with provided materials. Students may not use electronic staff paper for the sake of the class, due to the nature of the submission and being able to provide feedback.

**Course Description:** The purpose of the Sight Singing and Ear Training series is to facilitate the application of skills learned in Music Theory course work. The knowledge gained in Music Theory and its application in Sight Singing and Ear Training creates a foundation of general musical skills necessary for comprehensive musicianship. There are no prerequisites for this course, but concurrent enrollment in Music Theory I is required.

Course requirements: This course involves learning the techniques and skills necessary to aurally recognize and dictate the elements of common practice music theory, from basic intervals and scales to harmonically advanced chorale style musical phrases. Progressive technical knowledge of methods used in the ability to read existing musical examples will also be studied. Minimum objectives for the course will include the ability to pass four (4) quarter term exams with an accuracy level of 60%. As this is a **lab-based practice course**, some weekly journals and text submissions will be administered online, either independently or as a class discussion

board. Weeks with quizzes or quarterly exams will be given in lieu of the journals or text submissions. Periodic quizzes will also be administered. No examinations will be given without prior notification in class time.

## **Determination of Course Grade/Detailed Grading Formula:**

Grading is a weighted percentage distributed in the following manner:

General in-class quizzes/Singing quizzes/Performance quizzes: 50%

Journal/homework: 10%

Quarterly Exams: 40% (10% per exam)

These weighted grades are then combined and calculated on the following scale for the final course grade:

90% and above = A
80%-89% = B
70%-79% = C
60%-69% = D
59% and below = F
```

For sight-reading, scoring is based objectively on the number of elements correctly performed in each musical excerpt. The same applies to singing quizzes, which are administered individually. If a student is out of tune in the attempt, it is up to the discretion of the instructor whether credit will be given.

Additionally, excellent attendance and positive attitude may influence the student's final grade percentage.

Late Work, Make-Up, and Extra-Credit Policy: Missed examinations may be made up, but only if prior notification of the absence has been made to the instructor. If no notification of absence is given, the student must provide written documentation concerning the reason for absence before the examination may be made up. All examinations must be attempted to successfully complete the course. Late journals/homework will be accepted at a rate of loss of one letter grade per day late (i.e. if submitted after 11:59pm, that will be a B, the next day after 11:59pm a C and so on).

**Attendance Policy:** Attendance and promptness to all class meetings is expected. Attendance will be accurately taken at each class meeting. The instructor reserves the right to withdraw any

student who has missed more than three (3) class periods. As this course is designed primarily as a "lab" format, there are no "make-ups" available for missed class periods.

Chronic tardiness will result in the lowering of a grade by three (3) tardies equaling an absence. If entering the classroom late, please do so in an unobtrusive manner, as not to disturb those who are already working.

**Communicating with your instructor:** ALL electronic communication with the instructor must be through your COM email. Due to FERPA restrictions, faculty cannot share any information about performance in the class through other electronic means.
