Course Description: Introductory clinical course designed to provide a beginning level of education and experience in the implementation of direct client care. Emphasis is placed on the provision of basic care to adult clients and families in structured health care settings. Opportunities are provided for the application of theory, concepts and skills being acquired. Prerequisites: [ENGL 1301](#), [BIOL 2401](#), [BIOL 2402](#), [BIOL 2420](#), [PSYC 2301](#) with a grade of "C" or better. Co-requisites: [PSYC 2314](#), [RNSG 1331](#) and [RNSG 1413](#)

WECM End-of-Course Outcomes: As outlined in the learning plan, apply the theory, concepts, and skills involving specialized materials, tools, equipment, procedures, regulations, laws, and interactions within and among political, economic, environmental, social, and legal systems associated with the occupation and the business/industry; and will demonstrate legal and ethical behavior, safety practices, interpersonal and teamwork skills, and appropriate written and verbal communication skills using the terminology of the occupation and the business/industry.

Course requirements: (including description of any special projects or assignments)

- 1. Nursing Concept Map**-Assesses ability to create and implement a basic tool to systematically care for a patient.
- 2. SimChart (Electronic Health Record) Assignment** – Assesses basic knowledge of documentation practices and its importance.
- 3. Math Competency Exam** – Assesses proficiency in dosage calculations. Dosage calculation quizzes (3): Assess knowledge and understanding of dimensional analysis for the calculation of medication doses. Students must score 100% on the math competency exam.
- 4. Math Quizzes**—Prepares students for the Math Competency Exam.
- 5. Elder Portfolio** – Assesses knowledge and understanding of the needs of the elderly population in a community setting.

6. **Clinical Performance Evaluation-** The clinical evaluation tool is utilized to formatively and summative evaluate the student’s clinical performance based upon all clinical assignments throughout the semester. Students must meet all essential competencies marked with an asterisk on the clinical performance evaluation tool.
7. **Bring Your A Game**—Provides students with self-analysis of Work Ethics and reinforces core values of Work Ethics.
8. **Volunteer Hours**—Provides an opportunity for students to provide face-to-face volunteer hours in the communities in which we serve. Students must complete 8 hours volunteer hours. These are some examples of where hours can be completed: Food bank, Health care clinic, senior community center, Galveston Health District, feeding the homeless and health fairs. If the sites are not listed, they must be approved by the facilitator.

2.22 Late Assignments - All course assignments are expected to be completed and submitted to the assigned faculty on the specified due date and time stated by the instructor. Absence is not an acceptable excuse for a late assignment.

Make-Up Exams: Students will be allowed to make up a missed scheduled examination but will not be allowed to make-up missed quizzes. The exam make-up day will be set by the course facilitator. The makeup exam for unit exams will be an essay exam covering unit topics. If math problems are required on tests in the course, five math problems also will be on the make-up exam. The student in a course with a standardized final exam must take a make-up standardized final exam. If a student is unable to take the make-up exam on the date set by the course facilitator, a grade of zero will be recorded for the exam.

2.6.1 Theory/Lab Course Attendance Students are expected to attend every scheduled session for all classes. Instructors will keep an accurate record of class attendance. An absence is defined as missing half or more of a class period. Excessive absence is defined by nursing faculty as being absent for greater than three classes in nursing theory courses. A student will be given a warning for excessive absences. An instructor-initiated withdrawal may occur if a student continues to be absent after the warning is given.

2.6.2 Punctuality in Theory/Lab Courses Students arriving after the designated class start time will sit quietly at the back of the class until after the break. Students who are repetitively tardy will be given a warning by faculty. Repetitive tardiness is defined by nursing faculty as greater than six tardies in a single nursing course. Arriving late to class after a specified break also is defined as a tardy and counts toward the six
