 - If you would like you can order a hard copy of the text from the publisher or Amazon, but it is not necessary.
- I recommend downloading the Brightspace D2L App so you can keep up with class announcements and access the book and notes.

Course Description: Origin and development of the U.S. Constitution, structure and powers of the national government including the legislative, executive, and judicial branches, federalism, political participation, the national election process, public policy, civil liberties and civil rights.

Remember that this is an accelerated, asynchronous online course.

You are expected to be keeping up with reading, lectures, notes, and turning in assignments *weekly*. Keep this in mind before the semester drop deadline, <u>April 30th, 2025.</u>

Each week, I recommend listening to the lecture and looking at the corresponding notes, and then skimming the chapter, then completing the participation activity. Students who do that generally do well in the course.

- This is an online class, but I know lectures can sometimes be helpful. I post recorded lectures for most chapters we cover; I highly encourage listening to those.
 - For all the chapters we cover, I recommend listening to the lecture, looking at the corresponding notes, and skimming the provided chapter. Some students fill out their study guide as they listen to the lectures, some students take their own notes,

some just listen- whatever works for you. Students who listen to the lectures, skim the chapters, and look at the notes do well on the exams and assignments.

- I don't grade assignments via email! So please be sure you submit your work on D2L.
- I don't do make-ups/ re-grade assignments. If you don't follow the instructions for an assignment and it gets a 0, or you do poorly and get a low score, or you miss a participation assignment and get a 0, <u>that grade is final</u>- but I do offer extra credit to make up points.
- Since this is an online class exams are taken virtually with Lockdown Browser. You will need access to a computer with a camera and a quiet-ish room. Make sure to plan to have access to those things before the exams close in availability.
- You will not be able to use any material to take the exams (i.e. no study guide or notecard) however I do provide a study guide to help you study for the test! I will post a Kahoot the week of the test with example questions.
- You are expected to write your assignments in **your own words**assignments that are obviously generated by AI (includes tools like ChatGPT, Copilot, and Bing and other similar things, as well paraphrasing generators/translators) will receive no credit. On top of the zero, I will submit an academic dishonesty report to the College. *Please* don't do that!

Syllabus Quiz (5 points)

Students will take a brief quiz on D2L to demonstrate they are familiar with the class policies and have read the syllabus. It is 10 questions, does not need Lockdown Browser, and it should not take very long to complete.

The syllabus quiz needs to be taken on time; I will not reopen it. Syllabus Quiz due Sunday, March 16th at 11:59pm.

Exams (2 x15 points)

2 exams will be given throughout the semester. They will be multiple-choice questions with 5 short answer questions. I usually add 2-4 extra credit short answer questions.

You will take the exam on D2L with Lockdown Browser anytime during the days they are assigned. The tests will be worth 15 points each.

The two exams will encompass only material presented from the last examination. The exams will <u>not</u> be cumulative.

The exams will be taken with Lockdown Browser! Please be sure you are prepared to do that with a suitable connection, computer, and camera before the exams close. There are computer labs available on campus, with decent internet access if you need to use them! Exam policies:

- You are required to stay on camera for the entire exam.
- You may not stop and start- be sure you give yourself enough time to complete the exam all at once when you start it.
- You are required to complete a thorough room scan, demonstrating that you are not using any materials to aid taking the test.
- You will not be able to use any materials to take the tests. Referencing a study guide, notes, books, phone, or written material while taking the exam will result in a 0 for cheating.
 - However, to help you prepare for the exams- study guides will be provided on D2L. The exams are designed so that if you have interacted with the material, listened to the lectures/looked at the notes and chapters you will do well!

Exam 1 open April 10th-April 14th -- Closes April 14th at 11:59pm

Exam 2 open May 4th-May 7th. Closes May 7th at 11:59pm.

Participation Activities (6 x 5 points)

Up to 30 points will be awarded for class participation and response to 6 prompts.

These weekly writings should reflect an understanding of the material and demonstrate that the student has read the notes/skimmed the chapter/listened to the lecture as well as conducted additional research, if applicable.

Participation activities will be <u>due on Sunday evenings</u> throughout the course beginning March 16th and worth 5 points each (towards 30 total participation points).

These assignments will close after 11:59pm the day after they are due (so on Monday nights at 11:59pm) and I will not accept them late after they close on D2L. However, I will offer optional extra credit periodically to earn back some lost points if a week's activity is missed.

Participation activities are found on D2L in the weekly folders under Content (you can see the due dates on the schedule below as well).

Please follow the instructions for submission. Each activity will have different requirements as to accepted length.

<u>Topic Assignment and Position Paper (30 points total, 10 for topic assignment, 20 for position paper)</u>

This semester, students will write a position paper on <u>one of the following</u> public policy controversies in the United States:

- Should private businesses have the right to deny service based on their religious beliefs and practices?
- Should the U.S electoral college be changed or done away with?
- Should the U.S Congress be expanded?
- Should there be term limits for members of the U.S Congress?
- Should there be term limits for federal judges?
- Should political donations and election spending in the United States be more strictly limited?
- Should the U.S federal government legalize recreational drugs?
- Should the U.S federal government ban all animal testing?
- Should the U.S federal government ensure everyone earns a living wage?
- Should the U.S federal government ensure all Americans have access to mental health care?
- Should the U.S federal government assume control of public K-12 education in the United States?

To ensure a successful paper, there are 2 parts to this assignment. First the topic assignment, where you will choose your topic from the list above and then find at least 3 sources. Then I will grade that with comments and towards the end of the semester you will submit your final paper, which will be at least 1,000 words (about 3 pages), and have at least 4 sources on the works cited.

Topic Assignment (10 points) DUE March 30th at 11:59pm on D2L

To ensure that students will be successful for the position paper, they will first complete a topic assignment. Students will fill out the topic assignment worksheet (linked on D2L) to submit their chosen topic and at least THREE sources (on works cited in MLA, APA, or Chicago style) with a brief explanation on which topic they have chosen, which side they intend to take.

There is a worksheet on D2L that has every component you need for the topic assignment. It will be graded with comments, use these comments for the paper.

Position Paper (20 points) Due April 27th at 11:59pm on D2L

Write a paper taking a position (yes or no) on your chosen issue. Conduct research on the topic, citing at least \underline{FOUR} sources (adding at least 1 from the topic assignment) from credible and reliable publications, web sites, journals, books, etc.

Formulate an argument based on evidence in defense of this position and respond to the objections to this position. Explain how this position impacts the issues of personal responsibility and social responsibility. You will cite your sources within the body of the paper in parenthetical in-text citation.

The paper should be at least 1,000 words (approximately 3-4 pages), double-spaced, with 1-inch margins, and a 12-point Times New Roman Font, with a works cited page with correctly formatted MLA, APA, or Chicago style citations. There should be a works cited (not included in word count) and in-text citations throughout the paper.

Please use the template provided on D2L with the correct formatting and header.

Paper Guidelines:

- Format
 - Template on D2L, citation style on the works cited page can be MLA, APA, or Chicago (as long as it is consistent)
 - Times New Roman
 - 12 Point font
 - Correct header from the template that does not take up half the page.
 - Double-spaced
 - 1-inch margins
 - No end notes
 - Microsoft Word doc or PDF file
- 1000 words (aim for 4 pages) not including the works cited page
- Be sure to cite both paraphrased and quoted information. Do not use more than two direct quotes.
- You can use the following sources for topic assignment and paper:
 - Academic journal articles from library databases
 - Newspaper articles (not from editorial section) preferably from print media (like *The Houston Chronicle, The Austin American Statesman, Texas Monthly, Texas Tribune, The Economist, The Washington Post*, etc. As far as non-print journalism goes local news is usually acceptable, and NPR, AP, Reuters, C-Span, CBS News, and ABC News generally have decent reporting)
 - Government sites (the Texas government websites are regularly updated and maintained)
 - Research and polling institutes like Pew

- You may <u>NOT</u> use the following sources:
 - Wikipedia (good starting point to read about your topic, go to the sources that it links)
 - Pro-Con.org
 - Editorials
 - Blogs (including posts on Medium, Thought Catalog, etc)
 - o Random lawyers' websites
 - Avoid the lower tier news publications. This means NO Huffington Post, the Federalist, New York Post, CNN, Buzzfeed, The Daily Beast, Daily Mail, MSNBC, Fox News, OAN, The Blaze, Epoch Times, InfoWars, Occupy Democrats, Breitbart, Drudge Report, etc. etc.
 - Avoid interest group websites (e.g. ACLU, Planned Parenthood, NRA, etc) as they have an agenda in providing information.
 - You may not use papers you wrote in other classes.

Current Event Paper (5 points)

At the end of the semester, students will write a brief paper about a current event political issue.

- For this assignment, students will find a news article about a topic relevant to the class from a reputable news source (preferable print media reporting, such as *The Washington Post, Wall Street Journal, the Houston Chronicle* or another newspaper¹/ other reputable news is okay as well) and consider how it applies to concepts they have learned in the course.
- The article needs to be from a news outlet, written by a reporter (so not a government memo, or interest group bulletin).
- The chosen article should be recent (within a month of the due date). The article must focus on news that is pertinent to the **federal** government's actions and/or the interaction between the government and the people.

For the paper, students will submit a 1-2 (at least 1 full page) paper about the article. Your paper should be a brief summary and then an analysis of the article you have chosen. Analysis within the context of political science means that you are putting an action or a topic in the broader scope of government and its interaction with citizens. <u>So</u> <u>you will relate the article to what you have learned in this class.</u> For example, if you pick an article about something Congress is doing right now, you will explain what the article says and then relate that to things we learned over the semester like concepts of federalism, the powers of Congress, what we learned about the Constitution, etc.

Please provide in-text citations when you are summarizing the article and a properly composed works cited entry (MLA or Chicago is acceptable, APA if you must) of the article. There should be an in-text citation as well as a works cited entry for your article at the end of the paper.

Formatting will be the same as the position paper and there is a template provided on D2L with the correct formatting.
