Required Textbook/Materials: We will utilize American Yawp free online textbook. The link has been provided. You can view this textbook on the web or download a PDF format. Course Description: A survey of the social, political, economic, cultural, and intellectual history of the United States from the pre-Columbian era to the Civil War/Reconstruction period. United States History I includes the study of pre-Columbian, colonial, revolutionary, early national, slavery and sectionalism, and the Civil War and Reconstruction eras. Themes that may be addressed in United States History I include American settlement and diversity, American culture, religion, civil and human rights, technological change, economic change, immigration and migration, and creation of the federal government.

Course requirements:

Census day: Census day is 8/25. You must attend class by 8/25 or you will be dropped for non-attendance.

Attendance: Class begins at 7:10 AM. You are expected to be on time. If you are 10 minutes late you will be counted tardy for the day. I know sometimes things happen. Just please let me know.

Active Participation: Active participation in class is not group work. You will be given material to be prepared to discuss in class prior to the class. Active participation is answering questions posed by the instructor and being prepared by reading the material prior to class. Active participation is not doing work for other classes or texting on your phone.

Homework: Students are expected to read each assigned chapter each week, and any other material the instructor has given to prepare for class. Students are expected to read and prepare prior to coming to class. This will lead to class discussions and a better understanding of the chapters.

Discussions: Prior to class you will be given documents to read and prepare to discuss in class. This is in addition to reading textbook chapters. You should be prepared to discuss in class as part of the grade is participation. You will also upload your findings to D2L. See D2L for Instructions.

Exams: There will be **four multiple-choice exams** during the semester with a value of points each. Exam material will be drawn from quizzes, assigned readings, D2L/Brightspace assignments and all class activities. Students should pay attention to terms in the study guides and quizzes, available on D2L at the start of the module. Each exam may consist of multiple-choice questions, short answers, and map questions

Core Objective: Critical Thinking

Assessment Quizzes: In addition to the four exams there will be at least 10 quizzes. Quizzes will count for a total of 100 points (10 points each). Quizzes will be in class. Quizzes may consist of Multiple Choice, Short Answer or Map Quizzes. **Like exams, quizzes cannot be made up.** Missed quizzes receive a grade of zero. Quizzes are considered Pop Quizzes, which means they are not scheduled in advance, you should be prepared on any day to take a quiz.

Research Paper Assignment

Step 1- Post your topic on the appropriate Discussion Board by the due date in D2L. If you do not post your topic, you will not be able to move to Step 2.

Research Paper Draft: Students will turn in a Research Paper draft. Instructions are in D2L. Students must turn in a draft and view the feedback before you can turn in your final Research Paper. You must turn in a draft and then read the feedback your instructor gives before you can submit your final paper.

Step 3 – Final Research Paper: **Each** student will write a minimum of 5-page research paper over a topic in US History from 1492-1877, this paper should be in a research paper format and **NO LESS** than 5 pages, a works cited page should be included. Follow MLA formatting guidelines, including citations and a works cited page. Paper must be double spaced Times New Roman font, 12 points Please review rubric for grading criteria. Before you write your paper, post your topic in the appropriate discussion board. This is to make sure you choose a topic that falls into this class's scope. If you do not post on the discussion board and get your topic

approved, you risk receiving a zero for the paper. You must use at least 5 sources (**no textbooks**). You will also be required to use the COM Tutoring center or Tutor.com to receive feedback for your paper. If your paper is not at least 5 pages long, you will lose points.. If you do not complete this step you cannot move to step 4 – Oral Presentation

Students are **required** to use Tutoring for this paper, you may either use COM Tutoring or Tutor.com

You must complete the Steps in order to move to the next step. If you miss a step you cannot progress to the next step.

The Research Paper Assignment will be graded using the following formula:

Step 4 -Oral Presentations: Each student will create an oral presentation over the topic you wrote your research paper on. You will not read the paper but give a presentation telling us what you learned about the subject. Students will create their video on the appropriate assignment. The presentations should be 3-5 minutes long. The Oral Presentation link can be found in Content in the Research Paper/Oral Presentation Section.

Responsibility Paper:

Step 1 - Responsibility Paper Draft: Students must turn in a draft of the Responsibility paper. Students must turn in a draft and view all feedback to turn in the final paper. If you do not turn in the paper draft and read the feedback, you cannot turn in the final Responsibility Paper. (Step 2)

Step 2 – Final Responsibility Paper:: Responsibility Paper: Students will use one of the people listed in D2L and will write a two-page typed paper on the Social and Personal Responsibility of the person. The student must include a paragraph in their paper discussing the social and personal responsibility of the individuals involved. Please be specific when discussing personal and social responsibility. Students will use **primary and secondary sources** for their paper. You must have at least 3 sources. You must include a works cited page. You will also be required to use the COM Tutoring center or Tutor.com to receive feedback for your paper. If your paper is

not a minimum of 2 pages you will lose points in the area of Critical Thinking Skills. **NO TEXTBOOKS**

Example Topic: Harriet Tubman's decision to help runaway slaves, what are the consequences of her actions? What personal responsibility does she have and how does it influence those around her? What social responsibility does she have and how does it influence those around her?

Students are **required** to use Tutoring for this paper, you may either use COM Tutoring or Tutor.com

You must complete Step 1 to move to Step 2

All Paper Requirements: Points will be taken off for incorrect formats

- Spelling and capitalization need to be correct
- All papers must be typed, double spaced with a 12-pt. font
- All pages must have appropriately sized margins.
- All papers must contain information detailed in the procedure section of these guidelines
- Do not submit a paper you have used for another class.
- All Papers require a works cited page with sources that were used
- Do not use headings/subtitles on papers

Sources: Please use the COM Library for sources for all papers.

Sources NOT to use: Any encyclopedia, Wikipedia, History.COM, PBS, anything that ends in .org, NPS, NPR, Kahn Academy, no news stations, Whitehouse.gov, google books. Also do not use any article that does not show its sources. Most websites are not college level academic sites. Use the Library, you can do this online.

Extra Credit: All Extra Credit is already available in D2L. Please do not ask me for more extra credit, or alternate assignments if you fail to turn in assignments. I will not provide any assignments to replace missed assignments. This is the only extra credit that I will give you. Please do not email me and ask for more extra credit.

DUE DATES: All due dates are listed in D2L. Please utilize the Calendar, Announcements, and the assignments themselves for the due dates. Please do not email your instructor asking for due dates, they are listed in D2L.

Do not email your instructor assignments; all assignments must be submitted in D2L unless they are done in class.

Turnitin: All papers will be submitted to Turnitin. Please check your similarity report, this flags plagiarism. Also, Turnitin now checks to see if your paper was written by Artificial Intelligence, you will not see this percentage, but your instructor will. **Any percentage of Artificial Intelligence usage will result in a zero for your paper. Do not use Grammarly or any other online helpers to help you write your paper, it will show up as Artificial Intelligence.** There will be no rewriting of papers once the due date has passed. If you need help with papers, use the COM Tutoring Center.

I have run my discussion questions through ChatGPT so if your discussion resembles ChatGPT or any AI for discussion boards, you will receive a zero for the discussion.

No “Recycled Assignments for Course Credit: You may not re-submit an essay or discussion post (or portions thereof) that you did in another course for credit in this course, including material from one of my classes in an earlier semester. Therefore, even if you have done an assignment before in another class, you must do it from scratch this semester.

Feedback: To improve your writing, you should be reviewing feedback. When you upload your paper, you should review your similarity percentage and fix your papers.

Lockdown Browser /Respondus: Prior to taking exams, you will need to download the Lockdown Browser app to your computer, which must have a webcam and microphone. This app is required to ensure academic honesty, enabling you to take your exams from the comfort of your home rather than coming to campus or a testing center. On the D2L login page you will see a section titled Respondus Lockdown Browser. Please review the information and download the Lockdown Browser. You will take the syllabus quiz using Respondus to make sure you have it set up for exams. Your exam will prompt you to install or update the LockDown Browser before you begin.

Guidelines

When taking an online test, follow these guidelines:

- Ensure you're in a location where you won't be interrupted
- Turn off all other devices (e.g. tablets, phones, second computers) and place them outside of your reach
- Before starting the test, know how much time is available for it, and also that you've allotted sufficient time to complete it
- Clear your desk or workspace of all external materials not permitted - books, papers, other devices
- Make sure you are using the most current version of your web browser
- Remain at your computer for the duration of the test
- If the computer, Wi-Fi, or location is different than what was used previously with the "Webcam Check" and "System & Network Check" in LockDown Browser, run the checks again prior to the exam
- When using Wi-Fi, it's best to avoid networks that might have heavy traffic, such as libraries, bookstores and cafe

Make-Up Policy: There will be **NO** makeup tests or quizzes given. You are given dates for exams in advance. If you miss an exam you need to provide **DOCUMENTED PROOF** of why you missed the exam. Late work will not be accepted. Please do not ask for alternate assignments. If you have issues with an assignment, you need to see me **BEFORE** the assignment is due. I cannot help you if you contact me after the assignment is due. **Please do not email me missed assignments, all assignments must be uploaded to D2L.** I will substitute your lowest exam grade for one missed exam (this **DOES NOT** mean I drop a grade). I do not give extensions on papers as they are available for several weeks. The only situations in which a make-up exam will be allowed are **GENUINE AND DOCUMENTED EMERGENCIES**

If you have issues with an assignment, you need to see me **BEFORE** the assignment is due. I cannot help you if you contact me after the assignment is due.

If you have issues with the grade on an assignment **DO NOT** wait until the end of the semester to say something. I will not go all the way back to look at those assignments.
