This course is intended to provide students with an understanding of important macroeconomic issues. It will analyze macroeconomic foundations, covering 2 national income theory, economic growth, business cycle theories, inflation, unemployment, money and banking, and international trade

The homework assignments are critical to learning the course materials in economics. All work is grouped by Chapter and also by Unit. You will find it very difficult to be successful in the course if you do not complete your tasks on time and in an efficient manner. Because of the structure of this, and that the lowest grades are dropped, there is no late policy for work.

Graded homework on MindTap corresponds to the textbook content. The problem sets are typically due after the material is covered and it will be assumed you have read the assigned reading before attempting them. For many (but possibly not all) of these assignments you will be offered up to three opportunities to submit the correct answer and be given feedback for incorrect answers. Because of this grading scheme it is very easy to get 100% for your homework grade if you allow ample time to work on the problems. Students will have the opportunity to work and rework the homework assignments up until the due date.

Since work is posted on the first day of the course, there is nothing that is restrictive for students to work ahead.

Please pay close attention to the day and the time the assignments are due! To accommodate unforeseen emergencies, the lowest three homework assignments are dropped.

Practice Problems on Mindtap are not graded and therefore optional. They are an excellent way to learn course materials, prepare for graded assignments and tests. Please take advantage of these additional exercises.

"The Refreshing your math and graphing skills" practice assignment is intended for students who took math a long time ago. Most of you can skip it with no problem. It is quite lengthy and I do not expect you to complete it for practice purposes. Feel free to pick sections to go over if you think you need a refresher.

## 2. Readings (required but not graded)

You are expected to read the textbook and view the provided lecture videos. Not all the reading will be covered during lecture and oftentimes the lecture will contain content that is not in the reading.

## 3. Discussion Participation

Materials on the discussion board enhance your learning. You are required to make **one initial post and two replies** to each discussion topic. Your initial post **is required to contain outside sources that are properly cited** relevant to the topic.

The total score of the assignment is 10 points using the following rubric:

- 1. Discussion participation is 5 points
- 2. Effective use of written communication skills is 1.5 points
- 3. External sources and citations are 3.5 points

Discussion posts are open during the length of a Unit, so from the conclusion of the previous exam to the closing of the current exam.

Content matters more than length (quality vs quantity), however a quality post should be of a length to sufficiently address the topic in a satisfactory manner. A reasonable post expectation should be 2-3 paragraphs with a 1 paragraph response.

### 4. Exams and Exam Make-Up Policy

There will be four ONLINE exams via D2L. All exams will have 50 multiple-choice questions. The lowest of the four exams is dropped.

All exams MUST be taken by the deadlines outlined in your Course Schedule and Course Calendar and are available on the first day of class.

There will be no makeup exams. If you miss an exam or assignment, it is going to be counted as zero regardless of circumstances.

## **Grading Formula**

Your final grade will be calculated as the following:

Exams (3) 45% Homework 50% Discussions 5%

#### **Details:**

Each exam is valued at 15% of your overall grade, 4 Exams, drop the lowest.

Each homework assignment is the percentage of questions answered correctly, the lowest 3 assignments are dropped. Each assignment makes up 10% of your Homework Grade, or 5% of your overall grade.

Each Discussion Post (4 Total) makes up 25% of the discussion grade, or 1.25% of your overall grade.

# **Grading Scale**

The following grade scale will be used:

F = 59 - below

You can find the end of chapter multiple choice questions and problem sets on Mindtap in the form of assignments in the "Practice" mode, please work through them to help review materials covered in the chapter. You should also use the Study Guide (at the bottom of your Mindtap homepage) questions as self-testing tools to prepare for unit exams.

There are no considerations for grade 'adjustments'. All grades are finalized based on the performance of the student and their work.

## Late Work, Make-Up, and Extra-Credit Policy:

Due to the time structure of the course, that all assignments are available in advance, there is no late work policy. There are no Make-Ups for Exams. There is no Extra Credit. These exist due to the ability of students to complete homework tasks to achieve the score they desire.

Attendance Policy: Students will complete their first discussion post by the Census Date. Online classes are flexible, but not independent study. You are expected to log into D2L regularly, at least **four times a week** in order to complete tasks.
