



Course Description: (Prehistoric to the 14th century) A chronological analysis of the historical and cultural contexts of the visual arts from prehistoric times to the 14th century. Prerequisite: Eligible for ENGL 1301.

Course Requirements: This course consists of 3 parts: Chapter Assignments in REVEL, Discussion Board, and Class Exhibition in the blackboard

Determination of Grade:

Revel Chapter Assignments, Discussion Board, and Class Exhibition will be calculated into 100% scale. Then, the average of these three grades will be your final grade.

1) Chapter assignments (REVEL): Total 2500 points Blackboard>REVEL

Launch REVEL from your blackboard course page. You will work on each chapter by reading the interactive E-Textbook. You may also turn on the audio to listen to the chapter as you work through. At each chapter, you will take module quizzes (3 pts. each, 2 attempts allowed) and also chapter quiz (5 pts. each, 1 attempt).

The total points possible in REVEL is set to 2500 points. Each chapter carry a different total points due to various volume of contents each chapter offer.

The total points will be converted into 100% scale by the following step: Your final total points divided by 25

For example: Your final total point is 1850 pts. 1850 ÷ 25= 74 Your final grade % for REVEL assignments is 74 %.

Note: Grades points for REVEL chapter assignments will only be visible in REVEL, not in blackboard grade center.

2) Discussion Board: Total 200 points (50 points each x 4 assignments) Blackboard>Discussion Board

Read the direction for each assignment and post your response. Each assignment require minimum of 200 words. (30 pts.)

After submitting you will be able to view others' posts. Once submitted, you will no longer be able to go back to edit or delete your submission.

Read others' posts and reply to at least 2 others by leaving comments of at least two sentences each. (10 pts. each)

Total: 200 points= 100%

The total points will be converted into 100% scale by the following step: Your final total points divided by 2

For example: Your final total point is 180 pts. $180 \div 2 = 90$ Your final grade % for writing assignments is 90%.

Final Grade

For example: Your Chapter Assignment final grade is 78 %

Discussion Board final grade is 90%, and Class Exhibition final grade is 87.5%.

These three %s will be added and then divided by 3 to calculate the average grade %.

78 + 90 + 87.5 = 255.5

255.5 ÷ 3 = 85.17

Your final grade for the course is 85.17 % = B
