**Course Description:** This course is a study of utilizing the computer to develop and maintain accounting record keeping systems, make management decisions, and process common business applications with emphasis on utilizing a spreadsheet, data base and general ledger software.

**Course requirements:** Students will complete a variety of exercises such a Watch and Learn exercises, Case problems and Concept Exams utilizing QuickBooks 2022 via the BrightSpace (D2L) Learning management system.

**Determination of Course Grade/Detailed Grading Formula:** The final grade will be based on the quizzes given during the semester and completion of the minimum number of Lab and homework assignments.

(a) Concept Exams (100 points each): 60% of grade (b) Case Problems (quiz): 40% of grade
