**Course Description:** Government 2306 is an introduction to politics and government in the state of Texas. The purpose of this introduction is to acquire knowledge of the basic principles and practices of state politics.

This semester we will study federalism and inter-governmental relations, the political culture of Texas, the origin and development of the Texas Constitution, the structure and powers of state government, political participation, the election process, and issues in public policy.

This introductory course will also attempt to understand some of the basic questions and problems encountered in political science and political philosophy. For an introduction to these questions, we will read an essay "The Five Conceptions of American Liberty" by Carl Eric Scott to explore some of the basic concepts of political science.

# **Course Requirements**

**Course Exams:** There are three (3) Unit Exams. Each exam will cover the required textbook chapter readings, lecture notes, and additional readings. The exams will consist of multiple-choice questions.

**Short Papers:** There are (4) short papers (2 pages at a minimum) over a selected topic. Additional information on grading rubric, submission, format, citations, etc. will be provided in the assignment file. Submit in class.

**Research Paper:** Write a Position Paper on a specific controversy in current public policy discourse and debate in the state of Texas (e.g., Should marijuana be legalized in Texas?; Should Texas legalize casino gambling?; Should Texas prohibit "sanctuary cities?"; Should Texas prohibit the teaching of "Critical Race Theory" in public primary and secondary schools?; Should Texas reverse its voting laws requiring a government issue photo ID and prohibiting mail in ballots?; Should Texas introduce Covid vaccine mandates?; etc.).

Make sure that your paper is on a topic that is statewide in Texas in scope, and not an issue that pertains to the entire nation. The paper can cover an already existing policy or a proposed policy.

Write a paper on an issue in public policy. Explain and describe it in detail (what is the question of controversy at hand. Explain and describe the policy or proposed policy (what is the law, the executive action, the administrative regulation, or the judicial ruling) that has determined or could determine the policy? What is current policy and what is being changed? What does the policy do or intend to do?). Take a position on the policy or proposed policy (whether in favor of it or against it) and make an argument in defense of the position.

Conduct research on the topic, citing at least three sources from credible and reliable publications, web sites, journals, books, etc. The COM Library has a database to assist in research on many topics. Formulate an argument based on evidence in defense of the position you are taking. Also, respond to the most common objections to this position.

Explain how this position is related to the issues of personal responsibility and social responsibility.

The paper should be 1300 words (approximately 5 pages), double-spaced, with oneinch margins, and a 12-point font. Use a standard style for references, citations, and the list of sources (e.g., MLA, Chicago, or APA). Submit in class.
