Course Description: Study of the pathology and general health management of diseases and injuries across the life span. Topics include etiology, symptoms, and the physical and psychological reactions to diseases and injuries. A study of drug classifications, actions, therapeutic uses, adverse effects, routes of administration, and calculation of dosages.

Participation in Class Discussion

Class participation is an important part of the learning process in this course. You will be evaluated on the quality of your contributions and insights in the Case Studies as well as the Research Paper presentations. Quality comments possess one or more of the following properties:

- Offers a unique, but relevant, perspective.
- Contributes to moving the discussion and analysis forward.
- Builds on other comments.
- Avoid the “I feel” or “I like” syndrome. Include solid evidence, argumentation, or recognition of inherent tradeoffs. Your comments should demonstrate critical thinking.

Exams (15% of final grade): There will be Four (4) exams that are over specific modules that will be completed with Brightspace.

Mid-Term (25% of final grade)

Mid-Term will be over specific modules and will include information discussed during specified weeks. This will be completed in Brightspace.

Final Exam (25% of final grade)

Final Exam will be over all modules and will include information discussed with both books used in the course. This will be completed in Brightspace.

Participation (5% of final grade)

Students are expected to participate in Case Studies which will be found in weekly Learning Modules. The responses will be submitted in Discussion threads.

Research Paper (15% of final grade)

Students are to write a research paper (**minimum of 1500 words**) on a disease of the body system or organ which should include the mechanism of the disease: how the disease is diagnosed-the etiology, signs and/or symptoms, name of diagnosis, how it is treated, what type(s) of medications may be prescribed (**list 3 medication options**), what type of physician will treat the patient with the disease and prevention of the disease.

- The paper will be submitted to Instructor in email.
- The power point presentation will be emailed to the Instructor as well as posted to a Discussion Thread for all students to review and comment on for 5-point grade. {**student must post to two student's presentation as well as receive two comments on your presentation**}

Research paper will be presented in power point format as well as a written report which will be emailed to the instructor. * **The research paper is to be in APA format***

The paper will be graded using the following formula:

- Analyze and interpret primary and secondary sources - 20 points
- Effective use of critical thinking - 25 points
- Effective use of communication skills (Written) - 25 points
- Effective use of communication skills (Visual) - 25 points
- Discussion Board-(**You will need to comment on two Students as well as receive feedback from two students**) - 5 points

Success Tips for Students

Three Prior to Me:

The HIM faculty encourages students to problem-solve, work as a team as well as utilize available resources. To develop these skills, we will employ the “**Three Prior to Me**” process. This means that before you contact the instructor with a course-related question, you must have attempted to find the information in three other places. For instance, if you are unsure about the meaning of a term used in the course, you would attempt to locate this information in three places prior to asking the instructor. Hence, you might do a Google search for the term, ask a classmate, and refer to your textbook. Instructors **will** question you regarding what research methods you utilized to locate information on your own. This process is not meant to be a barrier to you, but instead to provide the following benefits:

- preparation for the workforce**
- increased research skills**
- instructors will have more time to provide feedback and interact with students**

If you have a question that **ONLY** the instructor would know the answer to (grade-related, assessments, etc.), then of course you would go to the instructor directly. This process will require practice and patience from the student as well as the instructor
