## **COURSE DESCRIPTION/BENEFITS:**

Understanding music through the study of cultural periods, major composers, and musical elements, illustrated with audio recordings and live performances. Course does not apply to a music major degree. This course, which meets the College's fine arts core requirement is designed for students with no previous training in music that wish to explore the meaning and forms of music: classical, romantic, contemporary, jazz, folk, pop. Prerequisite: TSIA2 ELAR <945 with Diagnostic 5-6 and Essay 0-4, <945 with Diagnostic 4 and Essay 0-8, or >945 with Essay 0-4, or equivalent developmental course with a grade of "C" or better.

## **Course Requirements:**

- 1. Login to Brightspace regularly to complete course assignments.
- 2. Take the Listening/Reading Quizzes.
- 3. Participate in the 3 discussions on Brightspace and reply to classmates as directed.
- 4. Complete and submit 3 performance analysis reports (details in Brightspace).

**Performance Analysis Reports:** You'll complete 3 performance analysis reports in Brightspace. Each report will cover music from a different historical era. Online concert options are provided in the assignment details, along with instructions and rubrics. If you have any questions or concerns, please reach out to me.

- Length: 1–2 pages, double-spaced
- Font: 12-point
- Submit your report via the Performance Analysis Reports assignment area in Brightspace
- Submit reports as a Word document (.doc/.docx)

- Week 7: Read Chapter 7 pages 182-201 from the book. Check presentation about the chapter and take the quiz. Performance analysis report 1.
- Week 8: Read Chapter 7 pages 207-260 from the book. Discussion 3 and Performance analysis report.
