Required Textbook: The textbook for this course is: <u>Mathematics for Elementary Teachers</u> by Musser, Peterson, Burger (10th ed.) The companion website is http://www.wiley.com/college/musser.

Course Description: Math 1350 is the first course in a two-semester course sequence designed to meet the mathematics requirements for students seeking to obtain an elementary teaching certificate. The course is a set theory approach to the development of the real number system, fundamental operations and concepts of arithmetic, systems of numeration, number theory with an emphasis on problem solving strategies and critical thinking.

Course requirements:

HW/Daily: There will be homework assigned for every section covered. Although the homework assignments themselves will not be submitted or graded, they reflect what to expect on the tests and quizzes. Your daily grade will be based on participation and in-class activities.

Quizzes/Exams: There will be four quizzes, four chapter-exams and a comprehensive final. All dates are in the course outline. There are no retakes on any of the quizzes or exams.

Determination of Course Grade/Detailed Grading Formula:

The course grade will be determined by the following formula:

Final Average = 60% Exam Average + 10% HW/Daily Average + 10% Quiz Average + 20% Final Exam
