Students are encouraged to consider coming to office hour often to get extra guided practice with the material. You can also email me to set up a meeting if the office hour time doesn't work for you.

Required Textbook/Materials: There is no required textbook for this course.

Recommended Textbook/Materials:

There are no required materials for this course. Students enrolled in any section of private voice instruction are encouraged to obtain a copy of Twenty-four Italian Songs and Arias, G. Schirmer, pub., from the College Bookstore. The instruction will determine if the student should obtain the "medium high" or "medium low" edition. The Naked Voice: A Wholistic Approach to Singing, W. Stephen Smith., Oxford University Publishers, also available in the College Bookstore. If a student is studying a substantial amount of repertoire from a particular source, then the student is encouraged to purchase that particular volume. However, any additional repertoire purchases shall be decided upon ultimately by mutual agreement of the teacher and the student.

Course Description: Private instruction on instruments and in voice is available to students majoring or minoring in music, and to other students who desire to gain or improve proficiency in voice or some instrument. Students must have their own instrument. Private instruction is an academic transfer course.

Course requirements: Attendance at all scheduled lessons, at least 2 performances in Tuesday Cohort, and performances in end of semester recital and jury.

NEW Tuesday Cohort: Students will be responsible to attend a mandatory (even if not singing that day) monthly masterclass for all individual voice students every second Tuesday of the month (for Fall 2025: September 9th, October 14th, November 11th) from 1-2pm in the Fine Arts Building, Room FA-110. This is a provided masterclass in conjunction with the students' weekly lesson. Students will volunteer or be assigned to sing for a masterclass and receive feedback from their own instructor as well as another instructor. There may also be time to receive

constructive feedback from peers. Before each Tuesday Cohort, students are asked to sign up in advance to sing on the sign-up sheet posted outside the fine arts office door. Students will work with their instructor to select the one song or aria to sing for the masterclass, and students will provide the collaborative pianist with a copy of their sheet music in a three-ring binder/double sided, or via PDF if the pianist finds it suitable. If time allows, volunteers to sing will be taken after the assigned students for the day. Students are expected to attend all 3 Tuesday Cohort meetings in the semester, however, one absence is allowed without consequence. Students are expected to sing at at least 2 meetings.

All voice students shall appear in the end of semester recital. The student and instructor will work together to prepare thoroughly for this event. The recital is November 18th at 1:00pm.

All voice students shall appear in the jury. At the jury, all or most instructors of music at the college will be present to provide feedback. Working together with their instructor, students must prepare at least two selections for their jury performance, and they may choose which they would like to sing first.

Late Work, Make-Up, and Extra-Credit Policy:

Make up lessons will be scheduled at the teacher's discretion.

Attendance Policy:

Regular attendance at lessons is required. The student is expected to email the instructor ahead of the lesson time should there be an absence or late arrival. Absences with prior notification will be recorded as excused at the discretion of the teacher. In most cases, an absence will be unexcused unless the teacher is notified in advance and the reason for missing is acceptable to the teacher. Tardiness to lesson times will accrue as an absence. For example, 50 minutes of time accrued in

tardiness = 1 unexcused absence (25 minutes for 1 credit hour lessons). If late for a lesson the student will be given only the time remaining in the lesson, unless the instructor is responsible for the delay. Students missing more than three (3) lesson times will be asked to withdraw from the course.

Communicating with your instructor: ALL electronic communication with the instructor must be through your COM email. Due to FERPA restrictions, faculty cannot share any information about performance in the class through other electronic means.
