Course Description: A general survey of various styles of music of the Americas, including but not limited to jazz, folk, rock, and contemporary music. This course which meets the college's fine arts core requirement is open to all students. Prerequisite: TSIA2 ELAR <945 with Diagnostic 5-6 and Essay 0-4, <945 with Diagnostic 4 and Essay 0-8, or >945 with Essay 0-4, or equivalent developmental course with a grade of "C" or better.

Course requirements: Participation in online discussions as well as completion of all online assignments.

Determination of Course Grade/Detailed Grading Formula: The final grade will be determined by the successful completion of the online components. Weight of each component is communicated on the D2L course shell.
