**Course Description:** The course is required for music majors and minors. The course surveys the principal forms, style periods, composers and their music through lectures and listening. During this semester-long survey, we will first cover the basic elements of music. After developing some skill in hearing/describing these parameters, they will be used in our study of the historical periods from Medieval to present.

Course requirements: Students are required to come to class prepared. One research paper and two concert reports are required. The papers are to be typed, or computer printed. 4-6 pages for the research paper and 1-2 pages for concert reports. These will be discussed in class.
