**1. Required Textbook/Materials**

The textbook used in this course is: Calculus with Applications, 11<sup>th</sup> edition, by Lial, Greenwell and Ritchey, published by Pearson.

A graphing calculator is needed for this course. A Texas Instruments TI 83 Plus or TI 84 Plus is recommended. A TI 89 or higher cannot be used in this course.

You will need access to the internet to gain access to course materials using the MML (MyMathLab) software. If you do not have your own internet access, you can get access on campus in the Innovations Computer Lab, TVB 1324, the Library and the Tutoring Center, TVB 1310.

**2. Course Description**

This course is the basic study of limits and continuity, differentiation, optimization and graphing, and integration of elementary functions, with emphasis on applications in business, economics, and social sciences.

## **4. Determination of Course Grade**

### **Grading Formula:**

The course grade will be determined by the following formula:

$$\text{Final Average} = 64\% \text{Chapter Exam Average} + 16\% \text{Final Exam} + 10\% \text{Homework Average} + 10\% \text{Quiz Average}$$

**The Final Exam score will replace the lowest Chapter Exam Score when it is larger.**
