**Course Description:** English 1302 (Composition II) is an intensive study of and practice in the strategies and techniques for developing research-based expository and persuasive texts. The course includes an emphasis on effective and ethical rhetorical inquiry, including primary and secondary research methods; critical reading of verbal, visual, and multimedia texts; systematic evaluation, synthesis, and documentation of information sources; and critical thinking about evidence and conclusions. The course also asks you to think critically about the ways that technology, smartphones, and social media shape our perceptions and experience of our cultural and political reality.

**Course requirements:** This is a lecture/workshop which also includes an online element in which the instructor presents and explains concepts about research and writing and the students engage in discussions about writing and the assigned readings and participate in group work both in face-to-face activities and online segments. The students are required to write different types of pieces in and out of class. These writing assignments include short reflective pieces and longer, researched essays. There will be no exams, but there may be short reading quizzes. Daily writing and reading are requirements for this course. The workshop portion of the class requires students to engage in discussions about writing and reading with their peers. The class stresses collaboration as well as independent writing.
