Course Description

**NURS 3352. HEALTH ASSESS ACROSS LIFESPAN (BSN)
(LECTURE 3, LAB 0). CREDIT 3. UDCM.**

This course focuses on comprehensive health assessment needs across the lifespan of the individual as a member of the family, community, population, and environment. Content includes access to healthcare, genomics, and traditional and complementary healthcare practices.

Course Requirements

1. **Weekly Quizzes (Weeks 1-5)** over assigned Chapters from Jarvis, C. & Eckhardt, A. (2020). *Physical examination & health assessment* (8th ed.). Elsevier.
 - a. Quizzes will appear in the Student Resources section of Evolve Resources for Physical Examination and Health Assessment, 8th Edition: **Course ID: 159818_dbauer65_1001**
 - Assignment due dates can be located in the Calendar section of Course Tools
2. **Shadow Health Digital Clinical Experience (DCE) Assignments (Weeks 2-8):** To comprehensively assess health history, physical examinations, and communication across the lifespan (Appendix A).
 - a. **Student must achieve an 85% DCE score on each assignment.** The assignment is formative and can be retaken until the 85% score is achieved.
 - b. **Synthesis of significant components and completion of health history:** Evaluates critical thinking related to the synthesis of significant components of a health history, competency when providing constructive criticism, and implementation of a health history (Appendix A)
 - c. **Head-to-Toe Assessment Across the Lifespan:** Assesses the ability to perform a bedside head-to-toe assessment to report normal and abnormal

findings, documentation, and a verbal SBAR (Appendix A).

3. **Face to Face:** Differentiates health assessment components across the lifespan. The student will sign up for three simulation classes that incorporates the **Head-to-Toe Assessment Across the Lifespan** (simulation lab A, B, and C – they do not have to be taken in sequence). Sign-up sheets will be posted.

4. **One Discussion Board:** Explores the integration genomic information as an adjunct to nursing assessment, and analyzes the legal and ethical implications of assessment findings, and patient information specific to genomic research.
5. **Participation / Attendance:** You are required to log in to your course weekly. Attendance will be taken by completion of each week's assignments.
 - a. **Assignment Due Dates:**
 - Assignments turned in by designated due date will receive the earned grade.
 - Assignments turned in 1-2 days late will receive the earned grade minus 10%
 - Assignments turned in 3-4 days late will receive the earned grade minus 20%
 - Assignments turned in 5-7 days late will receive the earned grade minus 30%
 - Missing assignments or assignments turned in after 7 days will receive an earned grade of zero
 - b. **Attendance will be worth 10% of Your Total Grade**
 - Assignments turned in by the due date will earn a "present" score of 100% for the week.
 - Assignments turned in after the due date will earn a "late" score of 50% for the week.
 - Missing assignments or assignments turned in after seven days will earn an "absent" score of 0% for the week.

7. Analyze the legal and ethical implications of assessment findings, and patient information specific to genomic research.
8. Investigate the use of traditional and complementary healthcare practices for the individual, family, population, and community.
