Schedule of Reading and Assignments

WEEK 1: Familiarize yourself with 'Housekeeping' and take syllabus quiz; start reading Plato's *Republic*.

WEEK 2: We will go over books 1-4 of Plato's Republic; Quiz one.

WEEK 3: We will go over books 5-8 of Plato's *Republic,* Discussion boards 1 and 1.5 will be due, as will the second quiz.

WEEK 4: We will go over book 9 and 10 of Plato's *Republic* and <u>take the</u> <u>test</u>.

WEEK 5: We will go over Aristotle's *Nicomachean Ethics*, books 1-4; discussion board 2 and quiz 3

WEEK 6: We will go over Aristotle's *Nicomachean Ethics*, books 5-7 **WEEK 7**: We will go over Aristotle's Ethics, books 8-10 (you can probably skip 9 tbh), quiz 4, and <u>take the test</u>.

WEEK 8: We will go over Machiavelli's *Prince*; discussion board 3 and quiz 5; Machiavelli test.

Please note: I didn't list the due dates for the quizzes or discussion boards. You will have to look at the course calendar for specific dates. This is just a general outline so you can see how the course will proceed and plan your studies.
