COURSE INFORMATION

Required Textbook: Invitation to The Life Span, 4th edition; by Kathleen Berger

Course Description: This course will provide an overview of human development, from conception to death. We will explore how people change over time in small ways and large. We will learn about three major domains of human development (biosocial, cognitive and psychosocial) at each life stage (infancy, toddlerhood, preschool, school-aged, adolescence, early adulthood, middle adulthood and late adulthood). Finally, we will deal with the topic of death and how we cope with the end of life in this society.

Course Requirements:

Classroom Structure

If you are absent from a class session that has a classroom activity or assignment, there will be no make ups and you will receive a zero for the activity/assignment.

Students are responsible for reading the chapters from the textbook, taking in-class notes, and participating in classroom activities and discussions. This class will not be a PowerPoint lecture class only. Although lecture may be used more on some chapters than others, critical thinking activities, in-class activities, web-based interactive activities, games, debates, video clips and other methods will be used to highlight important topics within each chapter. Your chapter exams will cover the information from the textbook as well as any activity, discussion, video, etc. that we cover in the classroom.

Students at COM are expected to participate in every session of all classes for which they are registered. Students are encouraged to respectfully ask questions, offer differing opinions, contribute to group discussions and give personal examples as it pertains to the class lectures.

The instructor reserves the right to revise the course syllabus as required by either judgment or circumstance. Changes will be announced in class and students are responsible for recording changes as announced.

Childcare Debate: 40 points

Chapters 3 & 4 discuss the first two years of a child's life. Trying to decide on childcare during these formative years can be very stressful for parents. For this assignment, you will prepare an argument either supporting or opposing various forms of childcare during these early years. Specific assignment and grading instructions will be given at the beginning of the assignment.

Children's Stories Activity: 50 points

Chapters 5 & 6 discuss the physical and social developments in early childhood. This assignment will allow you to use numerous children's books in order to expand your knowledge of key terms and theories related to early childhood development. The professor will provide you with the chosen children's books and will provide a more detailed explanation of the assignment on the specified activity date.

Advertising - Targeting Middle Childhood: 40 points

Chapters 7 & 8 focuses on middle childhood. Children in this age group are highly influenced by everything around them. For this assignment, you will look at how various forms/methods of advertising targets children in this age group. Specific assignment and grading instructions will be given at the beginning of the assignment.

Songs of Adolescence: 70 points

Two major concerns of adolescence are the formation of a personal identity and the development of social relationships with peers (of both genders). Songs that are popular among teenagers usually reflect these themes or others that emerge in our discussion of adolescent psychosocial development. In this assignment you will pick a song from your adolescent years and answer specific topic questions about the song. A grading rubric will be given prior to the assignment which will detail what specific questions should be addressed as well as other pertinent information.

Nursing Home Activity: 50 points

Chapters 14 & 15 focuses on Late Adulthood. Many adults in the stage of late adulthood feel worried and stressed when thinking about their independence, especially if they get to the point at which they need assistance. For this assignment, you will research different topics specifically related to nursing home residency as it relates to late adulthood. Specific assignment and grading instructions will be given at the beginning of the assignment.

Euthanasia and Physician Assisted Suicide Discussion/Activity: 50 points

The Epilogue Chapter discusses death and dying. One topic of debate in the medical and psychological fields is euthanasia and physician assisted suicide. For this assignment, we will focus on discussion topics related to euthanasia and physician assisted suicide. Specific assignment and grading information will be given at the beginning of the assignment.

YouTube Project/Presentation: 80 points

There will be one YouTube Project/oral presentation which is worth 80 points towards your final grade. You will find a 3-5 minute YouTube video that addresses any topic in the book. The video must be appropriate for the classroom. You will give an oral presentation to the class in which you will discuss why your video choice is significant and what you or what you hope others will learn from your video choice. A grading rubric will be

given to you several weeks before the presentation is due. Grading for this assignment will be based on the video content and your oral presentation to the class. There will be no make-ups for the presentations. You must be ready to present at the beginning of class on the assigned date.

What Have You Learned Review Questions: 320 points

At the end of each chapter, you will find a "What Have You Learned" section. These questions will be completed in the classroom once our discussion of the chapter is completed. There will be 16 sets of questions and will be worth 20 points each.

Chapter Exams: 200 points

There will be a total of 4 chapter exams; each exam will count for 50 points towards your final grade. Exams will be in the form of multiple choice, true/false and/or fill in the blank and will cover textbook information, chapter reviews, videos, class activities and discussions, class demonstrations and handouts. There are no make-up exams allowed. If you miss an exam, please speak with the instructor regarding possible extra-credit work.

Final Exam: 100 points

There will be a cumulative final exam, which will cover the material over the entire semester and will count for 100 points of your final grade. There will be no make-ups for the final. Any student that does not show up for the final exam will receive a 50-point deduction from their final total point accumulation.

DETERMINATION OF GRADE/DETAILED GRADING FORMULA

Grades are based on points accumulated throughout the semester. A variety of means to evaluate student performance will be used throughout the course. There is the possibility of earning 1000 points for exams, activities, presentations, etc. You are held accountable for completing all assignments. All directions for assignments must be closely followed.

Extra-Credit Policy: Extra credit assignments **may** be given throughout the semester if requested by student. To be eligible for extra-credit assignments, student must have missed no more than 3 class periods, must have submitted all assignments, and must have missed no more than one chapter exam. If these criteria are met, student has the option to speak with the instructor about completing an extra-credit assignment to supplement their final grade. No more than one extra-credit assignment can be requested.

Attendance and Participation Policy: Communication with your instructor is extremely important. If you are unable to attend class, call or e-mail your instructor prior to class if possible. Students are expected to attend each class. I will take attendance each class period. Regular attendance, classroom professionalism and participation are all critical components to being successful in this class.

Tardiness Policy: Students are expected to come to class on time and stay for the entire class period. 3 or more tardies or leaving class early 3 or more times will result in a student/teacher discussion and possible point deduction from your final grade. If you feel that there is a legitimate reason that you must be consistently late for class, please discuss the situation with me as soon as possible. If we have not had a discussion, you will be counted tardy.
