Category	Description

Comprehension	Explain key concepts and illustrate understanding of material by providing examples and personal perspective/experiences.
Connections	Integrate learned concepts by making connections to personal experience or previous understanding. Include requested items per assignment specifics.
Writing	Write clear and concise responses with no errors related to organization, grammar, format, and APA citations.
