Attendance Policy: Much of the learning occurs in the classroom setting through lectures and labs. It is difficult to learn all the concepts simply by reading the course textbook, although reading the textbook is essential to being successful in this course. Class participation is essential to learning. Many of the class sessions cover topics that have no handouts. Good note taking is important to be successful in this class. Attendance is taken each class period and excessive missed classes (6) can result in the instructor dropping you from the course. Coming to class late (more than 30 minutes) will be counted as an absence. Also, leaving the class early (before being released by the instructor) may result in an absence. WARNING: Your success in this 8-week course depends on your coming to class on time. You will miss quite a lot of material if you're not on time.
