Required Textbook/Materials:

The Beat Goes On: Popular Music in America, 5th Edition. Michael Campbell, Cengage, 2019

Course Description: A general survey of various styles of music of the Americas, including but not limited to jazz, folk, rock, and contemporary music. This course which meets the college's fine arts core requirement is open to all students. Prerequisite: TSI Reading 342 or equivalent development course with a grade of "C" or better.

Course requirements: 5 exams and a concert report

Determination of Course Grade/Detailed Grading Formula:

5 exams: 75%

Paper Assignment: 10%

Attendance/Participation: 15%

Late Work, Make-Up, and Extra-Credit Policy: Homework assignments will receive a ten-point deduction for every class day they are late. Classroom assignments may not be made up. Tests must be made up within two class periods (one week) of the original test date. It is the responsibility of the student to make arrangements with the instructor for the make-up test. Please note that the make-up test will be a different test than was originally given. **Extra Credit will be discussed in class.**
