## 1. Communicating with your instructor:

All electronic communication with the instructor must be through your COM email. Due to FERPA restrictions, faculty cannot share any information about performance in the class through other electronic means. I will make every effort to respond to your email within 24 hours of receiving it.

#### 2. Required Textbook/Materials

The textbook is Finite Mathematics with Applications, 13<sup>th</sup> edition, by Lial, Hungerford, Holcomb, and Mullins, Pearson Publishing Company. The e-text is provided with MyLab Math. Students will need a computer and internet service to gain access to the online assignments on MyLab Math. Students will also need to have a document scanning app on their phone to submit exam work.

#### 3. Course Description

Topics include introductory treatments of sets and logic, financial mathematics, probability, and statistics with appropriate applications. Number sense, proportional reasoning, estimation, technology, and communication will be embedded throughout the course

## 4. Course Requirements

**Homework Assignments (10%)** - There is a homework assignment for each unit covered. These are listed on the course outline (page 4) in this syllabus. Each day's homework assignments must be completed by 11:59 pm on the due date shown on both the course outline and on the list of assignments on MyMathLab (usually Sundays). You should do the assignments as soon as possible after reading the appropriate section in the textbook, and watching the associated lecture video. Although the answers for the homework are entered online, you should write your work on paper, neatly showing all steps, and keep it in your notebook with your notes for future reference. Your work will be a useful aid for preparing for quizzes and exams, and as a place to begin when seeking assistance from your peers, your professor, or the college tutoring center. **Quizzes (10%)** - Four quizzes which relate to the student learning outcomes, will be taken on MyMathLab. You can retake each quiz just once to improve your score; the higher score will be the one that counts. The quizzes must be taken in one sitting, they are timed, and the student gets only one attempt to answer each question. Be sure to label and write out your work/solutions for all quizzes in a neat and organized manner, *you may be asked to submit photos of your work in D2L for credit*. The work from these problems will also come in handy to review as you prepare for subsequent tests and the final exam.

**Exams (80%):** There are three exams which cover the chapters in the textbook and a comprehensive final exam. Tests must be completed within the given window stated on the course outline (page 4) and the student has two hours to take each exam once they start. There are no retakes on any of the exams. Be sure to label and write out your work/solutions for all exams in a neat and organized manner, *you will be required to submit photos of your work in D2L for credit.* The work from these problems will also come in handy to review as you prepare for the final exam. The final exam may be used to replace the lowest test score if it benefits the student.

## 5. Late Work, Make-Up, and Extra-Credit Policy

As a general rule, there are no make-up exams. Students must make every effort to complete the exam within the exam window. Extensions for exams will only be considered under extenuating circumstances. If you need to miss an exam, you must **petition the instructor prior to the exam window and have a legitimate reason.** Technological difficulties are not considered extenuating circumstances, and exam extensions are limited to one per semester. If you do not reach out prior to the exam, an extension will not be granted. All missed chapter tests will be assigned a zero, and the zero(s) will be used to calculate final grade in course.

Due dates for homework WILL NOT be extended (see Course Outline on pages 4-5 for due dates). Homework worked after the due date will receive a 20% deduction on all problems worked after the due date. You'll be able to work on past due homework and quizzes until the corresponding exam date. Any homework assignments or quizzes that are not finished by the due date of the related exam will be given a grade of zero at that time.

There is no guaranteed extra-credit for this course. Extra credit may be offered at the professor's discretion for completion of assignments or activities outside of the normal scope of the course.

## 6. Determination of Course Grade/Detailed Grading Formula

#### **Grading Formula:**

The course grade will be determined by the following formula: **Final Avg = 60%Unit Exam Avg + 20%Final Exam + 10%HW Avg + 10%Quiz Avg** \*The Final Exam score will replace the lowest Unit Exam score when it is larger.
