Course Description: Anatomy and Physiology I is the first part of a two-course sequence. It is a study of the structure and function of the human body, including cells, tissues, and organs of the following systems: integumentary, skeletal, muscular, nervous, and special senses. Emphasis is on interrelationships among systems and regulation of physiological functions involved in maintaining homeostasis. The lab provides a hands-on learning experience for exploration of human system components and basic physiology. Systems to be studied include integumentary, skeletal, muscular, nervous, and special senses. **Prerequisite: TSI Reading 351 or IRW 0320 with a grade of "C" or better. BIOL 1408 with a grade "C" or better is strongly recommended as a prerequisite but is not required.**

Course requirements:

Online Lecture Exams & Comprehensive Final Exam via BlackBoard

There are 4 online exams and 1 online comprehensive final exam (CFE). **Exams are administered in BlackBoard (BB) using Respondus Lockdown Browser with Monitor. Your computer must have a builtin webcam or you can purchase an attachable webcam.** Each lecture exam consists of multiple-choice, fillin-the-blank, matching, true-false, essay, and identification. Exam dates are listed in the "what's due when/?" document, will be open for 7 days (Wednesday midnight to Tuesday 11:59pm).

Online Lecture Quizzes via BlackBoard

There are 4 online lecture quizzes in BlackBoard (BB). Each quiz consists of 25 to 32 questions. You will have 60 minutes to answer the questions. Lecture quizzes are assigned the week prior to an exam. Lecture quiz due dates are listed in the "what's due when/?" document.

Mastering A&P Assignments

There are 10 online assignments in the Modified-Mastering A&P. Due dates are listed in the "what's due when/?" document **by 10:59pm on Saturday**. **Required online component**, you will access via BB from day one.

Online Lab Activity Quizzes (LAQ) via BlackBoard

There are 12 online lab activities. Each activity reinforces the material that will appear on the 2 scheduled lab praticals. **You are responsible for watching all videos uploaded to the Lab Material area for a lab activity.** You **MUST** log into **BB to complete the quizzes but are <u>not</u> required to use Respondus.** Lab quiz due dates are listed in the "what's due when/?" document. *Lab Practicals*

There are 2 lab practicals administered in lab. Practical dates are listed in the "what's due when/?" document.

Weekly Discussions via BlackBoard

There are 16 weekly discussions. These are not a required component of the course. Posts are worth 1 extra credit point added each week following the closure of the discussion to your overall final course grade. Posts can only be made during the week the discussion is open, no exceptions.
