Course Description: This course is designed to develop skills and understanding in the following areas: basic algebra concepts to include exponents, factoring and radicals; relations and functions, inequalities, algebraic expressions, and equations (absolute value, polynomial, radical, rational), with a special emphasis on linear and quadratic expressions and equations. Prerequisites/co-requisites: Prerequisite of TSIA2 Math Diagnostic 4. This course does not transfer.

Homework Assignments:

Homework for each section will be completed online using *MyMathLab*.

Quizzes and Exams:

Four online quizzes will be completed in *MyMathLab*. You can retake each quiz just once to improve your score; the higher score will be the one that counts. There will also be four unit exams and a comprehensive final. No retakes are permitted.

Required Technology:

- *MyMathLab* software is required for this class.
- A calculator is also required.
- Access to the internet is necessary to complete online homework, quizzes, and test reviews.

Determination of Course Grade: The course will be determined by the following formula:

$$\text{Final Average} = 60\% \text{Chapter Exam Average} + 20\% \text{Final Exam} + 10\% \text{Homework Average} + 10\% \text{Quiz Average}$$

Late Work, Make-Up, and Extra-Credit Policy: Your final exam grade will replace your lowest test grade. If you neglect to take a test by its due date, this grade will be the one replaced unless you have prior instructor approval to makeup this test at an alternate time. The late penalty for past due assignments is 20% of your grade. Occasionally, extra credit points will be offered to the entire class; however, individually, extra credit assignments will not be available.

Attendance Policy: Students at COM are expected to participate every week for which they are registered. Per COM policy, students are required to log on to their course at least twice per week, but it may be necessary to log on more times each week to complete the assignments required of this course. When students are not actively participating (e.g., contributing to discussions and completing weekly online homework), the faculty member can initiate an instructor drop and, subsequently, the student will receive a **W** for the course.

3. Recognize and use algebraic (field) properties, concepts, procedures (including factoring), and algorithms to combine, transform, and evaluate absolute value, polynomial, radical, and rational expressions.
4. Identify and solve absolute value and linear inequalities.
5. Model, interpret and justify mathematical ideas and concepts using multiple representations.
6. Model, interpret and justify mathematical ideas and concepts using multiple representations.
7. Connect and use multiple strands of mathematics in situations and problems, as well as to the study of other disciplines.
