Required Textbook: There is no required textbook for this course.

Course Description: A general survey of the major fields of theatre arts for students who have a limited experience or knowledge. The course emphasizes a mixture of hands-on experience and history. This course is a study and application of the various activities and methods of theatrical practice. It includes discussions, assignments, projects, and lectures designed to analyze and evaluate all aspects of the theatre experience: scripts, design, acting, directing, staging, history and criticism. Attendance at representative plays is required.

Determination of Course Grade/Detailed Grading Formula:

Grades will be determined based on qualitative (projects) and quantitative (papers and exams) formulas. 20% of your grade will be based on answering direct questions on an exam based on presentations and hand-outs. 20% of your grade will be based on two written reviews. 60% of your grade will be determined by completion of group and individual projects, or quizzes, which demonstrate a working knowledge of the concepts explored in the course.

Play Review Assignment Detail: You must see a performance of SFHS or COM Theatre productions. Optional extra credit for additional performance reviews. To get credit for attending you MUST say you are in Kinser’s Theatre Class and sign next to your name.

The best reviews for this purpose are approximately two (2) typewritten, double-space pages. It should be a discussion of what you experienced and how it affected you. The following is an OUTLINE of topics which should be addressed in your review. Your point of view and critical thinking skills will be the focus of your grade.

- I. Introductory Paragraph, including play and title
- II. Dramatic Values
 - a. Story/Plot)
 - b. Theme/Idea
- III. Personal reaction (A brief paragraph stating honestly what you think about the play)
- IV. Production Values a.
 - a. Scenery
 - b. Lighting
 - c. Costumes
 - d. Sound (music, special effects, etc.)
- V. Evaluate the Acting (use actors' names provided in the program, not the characters' names)
- VI. Identify and Discuss Contributions of the Director
- VII. Conclusion

Group Project Assignment Detail: The purpose of this project is that students will try their hand at collaborating creatively on a theatre production proposal and carrying out required elements depending on the roles selected. Creating theatre is a group endeavor, both from a creative and a business perspective.

Content Disclosure:

Courses within COM Theatre deal with works of dramatic literature, both on the page and on the stage. Late Work, Make-Up, and Extra-Credit Policy: Quizzes and video assignments automatically lose half a letter grade for each day the assignment is late. Make-up assignments are not permitted outside of emergency situations. Performances and group presentations cannot be made up due to scheduling.

Engagement Clarifications and Grading: The most important part of this class is showing up to the class. The in-class lectures and activities are the major tool for learning this craft. The student artist's questions and input are imperative to the learning process.

The student will receive an engagement grade for each class period on a point scale from “0” (lowest) to “5” (highest). These will add up to form the student’s Engagement grade for the semester. If absent, the grade is a “0” for the day. 5=A, 4=B, 3=C, 2=D, 1=F, 0=absent.

Engagement is not about simply going through the motions of “participation,” but requires you to be alert, prepared, and collaborative. To receive a 5 for the day, please offer either 2 questions or statements about the work in class. You can always email your comments or questions to the instructor should you wish to not speak out loud.

Attendance Policy: Timeliness and presence are crucial to excellence in the performing arts. Each student is allowed two (2) absences before your final grade is affected. Please arrive on time. If you do not feel well, do not come to class. If you have extenuating circumstances that affect your ability to follow these policies, you need to speak with the instructor BEFORE being late or absent. If you are impacted by COVID or Monkeypox, communicate with your instructor as soon as you are able, and modifications/accommodations will be worked out.

Communicating with your instructor: ALL electronic communication with the instructor must be through your email. Due to FERPA restrictions, faculty cannot share any information about performance in the class through other electronic means. Please do not use social media to communicate with me about classes.

Civility in the Classroom

Students are expected to assist in maintaining a classroom environment that is conducive to learning. Higher Education is challenging, and new to many of you. We are also in an unprecedented time, and many of you are facing difficult circumstances. We will discuss subjective works of art and the contexts in which they are created. Differences of opinion are welcomed and encouraged, but respect towards everyone in the classroom at all times is the expectation.

In the case of a violation of this policy, the instructor will talk with the student about the inappropriate behavior immediately and will follow-up after class or with a scheduled meeting. In the case of a second incident, the instructor will refer the student to the department head who will schedule a meeting with the student. At this meeting or any subsequent meeting, the chairperson will inform the student that repeated deviations from expected classroom behavior will result in removal from the class. If a third incident occurs, the instructor will ask the student to leave the class. If the student refuses, the Campus Police will be called to remove the student. The student will be immediately dropped from the class and reported to the student Office of Student Conduct.

A Word about BOUNDARIES:

At COM Theatre we strive to champion a professional atmosphere of non-judgmental inclusion, open communication, and enthusiastic consent so that all involved can feel free to be a pro-active participant in their own artistic growth. It is crucial that you gain an ever-evolving awareness of

your own personal boundaries, so that you may teach those boundaries to us – in order to assure the personal comfort and safety of yourself, your partners and the ensemble. Please feel free to inform instructors of any physical or emotional limitations that may hinder your performance of any techniques/material presented in class so that they may be appropriately adapted. In performance-oriented classroom or production situations, it may sometimes be necessary during the use of techniques and exercises for the Instructor/Director to interact physically with students or for students to interact physically with one another. This is part of the learning process, and any contact is intended to be professional and clinical in nature. If at any time a student is uncomfortable with the idea or the practice of that physical contact, the student will be given an opportunity to voice their concern and the need for adaptation will immediately be respected without fear of reprisal, reprimand, or dismissal

Course Outline:

This outline is subject to change during the semester. Students will be notified immediately of any changes and will be given the appropriate time and accommodations in the event of those changes.

Week 1-Introduction to class, Review Course Syllabus, Classroom Expectations, discuss course requirements and projects. Students will choose one page of written material (a poem). Handwrite it onto paper. Present to instructor, be quizzed on comprehension. Student will present material (formally) to class following presentational expectations of physical, vocal and comprehensive expectations. Student will learn various methods of memorization, rehearse and present material a second time, memorized and evaluated via a presentational rubric. Students will also be evaluated on their audience participation and feedback.

Week 2- Students will finish any presentations. Students will learn about pantomime and story structure. Assignments will include script scoring, presentation of individual pantomime, and audience participation and feedback

Week 3- Students will finish any individual pantomime presentations. Students will explore the concept of improvisation and scripted monologues. This weeks graded evaluation will be based on participation

Week 4- Students will present memorized monologues and be evaluated based on provided rubric and audience participation and feedback.

- Week 5- Students will discuss and read scripted material including duet scenes and group scenes. Student will choose partners, scripted material and learn character analysis. This week's evaluation will be based on participation.
- Week 6- Students will learn about stage directions and standing positions. Students will proceed to block their group scenes and rehearse in anticipation of formal presentation.
- Week 7- Students will begin Group Project activity, this activity will include Character analysis and development, Script structure, including protagonist and antagonist, scripted exposition, conflict and climax/resolution. Students will begin crafting scripts. Evaluation will be ongoing, portfolio based on project work.
- Week 8- Students will continue Group Project activity, this activity will include Character analysis and development, Script structure, including protagonist and antagonist, scripted exposition, conflict and climax/resolution. Students will continue crafting scripts. Evaluation will be ongoing, portfolio based on project work.
- Week 9-Students will learn about Scenery and Costumes, how these enhance a scene/play.
- Week 10-Student will spend some time Exploring Theatre Lighting, how it changes mood and feeling.
- Week 11-Idea Board/Collage Rendering due Tuesday by the end of class based on character/scene
- Week 12-Applied Theatre Scene Rehearsal
- Week 13- Work on Final Group Creative Projects in class Workshop with feedback.
- Week 14-Group creative projects
- Week 15- Final Group Project Presentations Final peer evaluations and presentation materials due at presentation
- Week 16- Presentation of Group Projects, Individual Feedback/Critique/Observation papers due.
