Course Description

This class examines the scientific study of human society, including ways in which groups, social institutions, and individuals affect each other. Causes of social stability and social change are explored through the application of various theoretical perspectives, key concepts, and related research methods of sociology. Analysis of social issues in their institutional context may include topics such as social stratification, gender, race/ ethnicity, and deviance.

Syllabus Modifications

The instructor reserves the right to modify the syllabus and course calendar during the course. Should any modifications be made, the instructor will notify students in writing (via an announcement in D2L Brightspace) of the changes.

Late Submissions

A quiz completed after its deadline will incur a 50% reduction of the score on the quiz (i.e., a 7/10 will count as 3.5/10). Discussion boards have end dates after which students will not be able to post, so discussion posts must be submitted by the due date in order to receive any credit. The reflection paper, due Wednesday, July 3, will incur a 50% point reduction if submitted any time on Thursday, July 4 or up to noon CST on Friday, July 5 (e.g., if you submit the paper on Thursday and score 8/10, your grade will be 4/10). Papers received after noon CST on Friday, July 5 will not be graded.

Early Submissions

The submission of an assignment is an indication to the instructor that the assignment is ready to be graded. Assignments that are submitted and graded before the due date are not eligible to be resubmitted and/or revised for a higher grade. If you have questions about an assignment, please communicate with the instructor prior to submitting the assignment.

Communicating with your instructor

All electronic communication with the instructor must be through your COM email. Due to FERPA restrictions, faculty cannot share any information about performance in the class

through other electronic means. (Faculty may add additional statement requiring monitoring and communication expectations via D2L Brightspace.)

The Use of Generative Artificial Intelligence

Since this course intends to cultivate writing, critical thinking, and analytical skills, all assignments that require writing should be prepared by the student. Students should not have another person or entity do the writing of any substantive portion of an assignment for them; this includes hiring a person or company to write assignments and using artificial intelligence tools like ChatGPT. Doing so is not permitted and will be treated as plagiarism (see "Academic Dishonesty" below).

Academic Dishonesty

Academic dishonesty includes (but is not limited to) cheating on a test / quiz, plagiarizing, stealing or dishonestly accessing the instructor's materials, and colluding with other students. If you engage in any form of academic dishonesty, disciplinary action will be taken in accordance with the COM Student Handbook and Office of Student Conduct. Plagiarism, at a minimum, will result in a 0 on the plagiarized assignment.

Incomplete Grades (The "I" Grade)

The instructor has the right to grant or deny students' requests to take an incomplete grade at the end of the semester. I will grant requests to take an incomplete if the student making the request satisfies the following two conditions: (1) The student has submitted all discussion posts and taken all quizzes on time throughout the first 3 weeks of class (through Sunday, June 23), and (2) the student experiences a documented emergency or an unforeseen-and-unpreventable circumstance that impedes the completion of the course. If both conditions are satisfied, I will draft an "Incomplete Contract" for the student to sign that specifies the work that the student must do and the due date for this work. At this due date, the incomplete grade ("I") will be changed to an A, B, C, D, or F. If the two conditions above are not satisfied but a student feels that his/her/their circumstances warrant an incomplete, please e-mail the instructor with an explanation of these circumstances.

Speaking frankly, incomplete grades are not commonly issued in my classes. I understand why they are sometimes necessary and I am happy grant requests for them when the two conditions outlined above are met. However, I've found that doing work on time and maintaining communication with the instructor when you encounter difficulties can resolve most of the problems that lead to requests for incomplete grades.

Institutional Policies and Guidelines

Grade Appeal Process: Concerns about the accuracy of grades should first be discussed with the instructor. A request for a change of grade is a formal request and must be made within six months of the grade assignment.
