**Course Description:** This course is an overview of the skills and knowledge necessary for the field of facials and skin care. Instruction will demonstrate the theory, skills, safety and sanitation, and professional ethics of basic facials and skin care and explain the rules and regulations of the institution, department and state. This course is offered for Esthetic Specialty only.

**Course requirements:** Demonstrate professional ethics, sanitation and safety. Demonstrate the rules and regulations of the institution, department and state. Texas Department of Licensing and Regulations (TDLR) Administrative Code / Chapter 83.100 / Sec. 83.101 / Sec. 83.102 & Sec. 83.103 Students are expected to assume the responsibility for learning. Your instructor will assist you, but the actual responsibility rests with you. Students are also expected to devote their energy to attaining the skills and knowledge required for their career goals.

Late Work, Make-Up, and Extra-Credit Policy: Late work will be deducted 10 points for each day it is late. Any MindTap activities needing extended dates will be 10 points deducted for each request. Makeup work must be completed in a timely manner. It is your job to get your missed assignments the first day you return to class. The due date will be determined for the assignment at that time. If it is not turned in by the determined due date, it will be counted late and points are then deducted according to the late work policy. Practical sheets must be completed in its entirety to obtain a grade of 100. If the practical sheet is not complete at the end of class, it is a zero grade. Any practicals not completed according to the book, with proper draping and patron protection, <u>WILL NOT</u> receive a signature. If the practical sheet is lost, the signatures will also be lost and the student must start over.

Attendance Policy: The faculty believe that experiences in the classroom and laboratory cannot be adequately duplicated if a student is absent. In addition, the Skin Care / Cosmetology Programs are designed to teach professional work habits, such as attendance. Every class is important to your success in school, and you must, first, go online and self-screen before entering the building at www.com.edu/selfscreen . Make every effort to attend all classes if you do not have any symptoms listed from the online screening. In the event you have COVID or have been in contact with someone who tested positive for COVID, you must self-report at <a href="https://www.com.edu/coronavirus/self-report-gateway">https://www.com.edu/coronavirus/self-report-gateway</a> and stay home for the designated amount of time. Those who have no symptoms and have self-screened should sign in on the sheet that will be provided in each class. Excessive absences in either lecture or lab will result in a dismissal from the scheduled class. Students arriving late (after 5:15pm) or leaving early (before 10:15pm) or before class is dismissed is considered a tardy. IF you are not back at the designated time for break, you will be counted tardy and it will affect your attendance.

Any student missing more than an hour of class per day, will be counted absent. Any time past 4 absences, will result in being dropped from the class. Dr. notes will no longer be an automatic excused absence. Excessive absences, four (4) days missed, in either lecture or lab will result in a dismissal from the program. Missing more than an hour of class is considered an absence. Remember 4 tardies equal 1 absence. A tardy is if you arrive after class starts or if you leave before class is dismissed as well as late returning back from lunch.

Additionally, HB 1508 authorizes licensing agencies to require reimbursements when a student fails to receive the required notice.

**Grade Appeal Process:** Concerns about the accuracy of grades should first be discussed with the instructor.
