**Course Description:** A survey of the social, political, economic, cultural, and intellectual history of the United States from the pre-Columbian era to the Civil War/Reconstruction period. United States History I includes the study of pre-Columbian, colonial, revolutionary, early national, slavery and sectionalism, and the Civil War/Reconstruction eras. Themes that may be addressed in United States History I include American settlement and diversity, American culture, religion, civil and human rights, technological change, economic change, immigration and migration, and creation of the federal government.

**Course requirements:**

**Writing Assignments-** At the beginning of the course, students will be provided with a few topics to choose from. Students will select an outside primary or secondary source that relates to one of the topics. In a One Drive document, the student will answer three questions about their selected source. The purpose of the One Drive format is so that the instructor can provide feedback on a regular basis so that the student may revise the document before the final turn in. The final products will be turned in by providing a link to the document in Brightspace. Further instructions will be available on Brightspace. The final turn-in date is 8/5

**Map Assignment-** During the course, students will identify five geographic locations relevant to lecture materials. Using instructions found in Brightspace, students will create a Google Map featuring those five locations. Included in the location's description should be the name of the location and at least one paragraph detailing the location's importance and relevance to course material. The final turn in date is 8/2

**Discussions-** Each week students will be assigned a reading to supplement the lecture. One day of each week we will conduct a virtual discussion of the reading. To receive full credit a student must contribute to the discussion 5 times. To receive credit students must make a significant contribution to the discussion, simple closed ended answers like "I agree" or "yes/no" will not count. Discussion Boards will be in each unit module.

**Unit Quizzes-** At the end of each unit, students will have a 5-question quiz. The quizzes will be multiple choice questions based on the key terms from each lecture.
