## Course Description: (LECTURE 3, LAB 0). CREDIT 3. WECM.

This course is an examination of the profitability factors of plant operations including both personal and business strategies, objectives, and operating profitability. Students will be able to summarize plant operations from a business perspective; explain the impact of operation on profitability; and interpret stock market factors and annual reports. Prerequisites: <u>PTAC 1302</u> and <u>MATH 1314</u> or <u>TECM 1343</u> with a grade of "C" or better

Course requirements: Excel, Internet, PowerPoint, TEAMS, and Word (all Microsoft software)
