### 1. Required Textbook/Materials

The textbook used in this course is: Finite Mathematics with Applications in the Management, Natural, and Social Sciences, Twelfth edition, by Lial, Hungerford, Holcomb and Mullins, Pearson Publishing Company.

A graphing calculator is needed for this course. A Texas Instruments TI 83 Plus or TI 84 Plus is recommended. A TI 89 or higher cannot be used in this course.

You will need access to the internet to gain access to course materials using the MML (MyMathLab) accessed through your D2L Brightspace course. If you do not have your own internet access, you can get access on campus in the computer lab 332 on the 3<sup>rd</sup> floor of the STEAM building, the Library, and the Tutoring Center, ICB 109.

#### 2. Course Description

The application of common algebraic functions, including polynomial, exponential, logarithmic, and rational, to problems in business, economics, and the social sciences are addressed. The applications include mathematics of finance, including simple and compound interest and annuities; systems of linear equations; matrices; linear programming; and probability, including expected value.

### 3. Course Requirements

#### **Homework Assignments**

There is an assigned homework for each section to be completed online using MML.

#### **Ouizzes and Exams**

There are 4 quizzes, 4 chapter exams and a comprehensive final exam. All of the quizzes and exams are to be done online using MML. You can retake each quiz just once to improve your score; the higher score will be the one that counts.

There are no retakes on any of the exams.

#### 4. Determination of Course Grade/Detailed Grading Formula

#### **Grading Formula:**

The course grade will be determined by the following formula:

#### Final Average = 64%Chapter Exam Average + 16%Final Exam + 10%Homework Average + 10%Quiz Average

#### The Final Exam score will replace the lowest Chapter Exam Score when it is larger.
