Required Textbook: All books are online for free.

Course Description: This course is a survey of the development of British literature from the Enlightenment period until the present day. Students will study works of prose, poetry, drama, and fiction in relation to their historical, linguistic, and cultural contexts. Texts will be selected from a diverse group of authors and traditions.

Course Prerequisite: English 1301 with a C or better.

Course requirements:

There will be a research assignment. There will be at least one oral presentation. In addition, you will be required to read every night and participate in class EVERY DAY. There will be a midterm, final, and a paper.
