Course Description:

NURS 3354 Legal & Ethical Issues in Healthcare (Credit 3: Lecture 3, Lab 0) (5-week course, 48 contact hours). This course explores the application of law and ethical principles related to nursing in differing practice areas.

Course requirements:

1. Discussion board/video assignments (3): Assess knowledge and application of course content. Discussion board/video assignment topics will be from the weekly reading content. Students will post one significant post related to the course content and a support post with cited references. Students will reply to two of their peer's/instructor's posts with cited references. If a student receives a grade below 70% on any discussion board rubric, the student should schedule a counseling appointment with the instructor to complete remediation.

2. Case studies (4): Assesses overall knowledge and application of complete course content. Case studies will meet QSEN/NLN competencies, including teamwork, collaboration and professional identity, evidence-based practice and spirit of inquiry, and safety and nursing judgment. If a student receives a grade below 70% on any case study, the student should schedule a counseling appointment with the course facilitator.

3. Weekly Participation/Professionalism: Assesses the ability to synthesize information when collaborating on a topic with peers. Students will discuss components of evidence-based research via discussion board. Students will be expected to synthesize content for the discussion post and support their responses with cited references. Students will be required to synthesize postings from

two peers/instructors and contribute substantially to the post with new information, either supporting the peers/instructors' view or offering a different view with supporting references. Professionalism:

a. Attendance – Student is present in the class per institution attendance requirements.

b. Timeliness – student submits assignments on time.

c. Participation and engagement—Students participate in class and team activities in a meaningful and engaged way 2 days/week.

d. Preparedness – student completes all assignments and pre-class assignments.

e. Professional demeanor – Student communicates professionally throughout the course period.

f. Objectives Application – Students will apply the objectives of this class to all classwork and assignments.

g. Teamwork – student participates in teams collaboratively and professionally.

4. Quizzes (5): These assess overall knowledge and application of complete course content. Students will complete quizzes as assigned, each due at midnight on the assigned deadline. The student will have two attempts to complete each quiz. The recorded grade will be the average for the two quiz attempts. The quizzes will be timed and taken on Respondus.

5. Term Paper (1): The term paper written assignment is a comprehensive paper in which the student must choose an ethical principle or theory as a foundation to develop a personal nursing perspective. Utilizing the personal nursing perspective, the student must analyze the roles of the baccalaureate-prepared nurse, including Provider of patient-centered care, Patient safety advocate, Member of the Interdisciplinary Team, and Member of the Profession.

6. Reflection Paper/Journal (2): To actively engage with course content by critically analyzing personal experiences, identifying key takeaways, and connecting theory to practice. To use insights from reflections to inform future study strategies, decision-making, and professional development.
