## **\*Topic Discussions**

**In-Class Discussions** – take place in class. Students will have the opportunity to be a part of the discussion of each topic. This is a reflective time that will occur at the individual and group level (students should distance in accordance with College policy). Directions and instructions will be offered in class, reminders may be sent via email/online. The Course Calendar offers a general guide

### **Online Discussion via Discussion Forums**

- Online Discussions offer the student the opportunity to make connections from the course material to their experiences/events occurring in the world around them.
- Two posts are required to earn points. Be genuine, be polite, be sincere, and engage
  - **Post 1:** Reply to the question/statement made by the course professor. Use the required term(s) in your post. Write in complete sentences using correct grammar and spelling. End your post with a question that relates to the topic/or your post. Follow the word/sentence requirement. Use the assigned textbook, do not use any other source
  - **Post 2:** Reply to a post made by a classmate. Begin your response with the classmate's name. Write in complete sentences using correct grammar and spelling. Adhere to the word/sentence requirement. Do not write the words "good job or similar language." The goal is to simulate conversation that would take place in the classroom. You are writing what you would say if we were in class (on-campus) discussing the topic with your classmate. Follow the word/sentence requirement listed.

#### \*Video/Article Quizzes

• Assesses the student's understanding of an event. Short quiz over a video or article. Students have two attempts! If a student attempts a quiz a second time, the student's final score will be the points earned on the second attempt. Do not attempt a quiz a second time if one is satisfied with one's initial score. Do not click on the quiz a second time if one is attempting to see points earned or questions missed. The student can see the points earned by selecting the My POINTS (grades) link

### (3) Exams – What did you learn?

- When a student completes the assigned reading and completes the offered assignments, the student will assess their knowledge of the material by taking an exam. The student can see the points earned by selecting the My POINTS (grades) link. These are the only exams offered. There is no course "final exam." In this modern day with many technological resources, one may experience a technological glitch or problem. The student will receive ONE (1) reset if needed for the course no exceptions. Plan ahead! Locate location that is quiet, free of interruptions and has a secure Internet connection. Do NOT attempt to take the exam on one's phone.
- (4) **Position Paper.** This assessment offers the student the opportunity to engage in discussion regarding a social issue that is also a political issue. The assignment:

Write a Position Paper on a current public policy controversy in the United States (e.g., Should Private Businesses Have the Right to Deny Service Based on Their Religious Beliefs and Practices? Should Marijuana Be Legalized? etc.). The student must take a position (yes or no) on a current public policy controversy. Conduct research on the topic, citing at least three sources from credible and reliable publications, web sites, journals, books, etc. Formulate an argument based on evidence in defense of this position and respond to the objections to this position.

Explain how this position impacts the issues of personal responsibility and social responsibility. Not only will students submit a written paper on social/political issue, the student will give a 5-8 presentation.

Prior to submission, the student must do the following (be sure to plan ahead):

- (3) Revise your paper after the session
- (4) Submit a report (email from the Tutoring Center)

## Paper Assignment Guidelines

- Format: Chicago Manual Style (CMS) Author-Date.
- Times New Roman
  - o 12 point
  - Double-spaced
  - 1-inch margins
  - <u>NO footnotes</u>
  - Microsoft WORD file format (.doc or .docx)
- <u>1000 words (without a title or reference page)</u>
- Include a title page and a reference page
- When you cite, use a direct or indirect quote, but you can only use ONE direct quote per paper.
- Insert <u>citations</u>
- Do not use subtitles
- You can use the following sources as citations:
  - Academic journal articles
  - Newspaper articles
  - Data and articles from government websites or research institutes such as Pew Research Center
- You CANNOT use the following sources as citations:
  - o Wikipedia
  - Procon.org
  - Any other blogs, <u>non-academic websites</u>
  - Editorial page in newspaper
- You CANNOT use or cite papers you wrote before.
- If the student does not the minimum requirements, the student will receive a .05 as a grade and be offered the opportunity to rewrite and resubmit. Each student has one opportunity for a "rewrite" and must be submitted by the "redo due date"
