Course Description: This course is designed to provide you with a fundamental understanding of government and politics in Texas, but especially the following topics: Origin and development of the Texas Constitution, structure and powers and state and local government, federalism and inter-governmental relations, political participation, the election process, public policy, and the political culture of Texas. Ultimately, my goal for you in this class is to become an informed and critical thinker as well as a participant in American politics. You will also learn about current political debates, the 2020 elections, and the 2021 legislative session in order to understand the impact of Texas politics on your life.

Course Assignment: All assignments will be submitted via [Blackboard \(Bb\)](#)

1) Attendance and Participation (5%)

- Attendance and participation will be measured based on the following criteria:
 - Submitting assignments on time.

2) Homework (15%): The deadline is 11:59 pm the following day

- Homework includes:
 - (1) Reading assignments: In addition to the textbook, you must read all reading materials in the content folder.
 - (2) Discussions (**D**): The instructor posts a thread on the Discussion Board every week. You are required to post your reaction (click “Reply”) to share with

your classmates. There is no minimum word requirement, but you must post at least one comment each week. Read your classmates' comments as well.

(3) Journal (**J**): After finishing the reading assignments, you are required to post your reaction on the Journal. The minimum requirement is one paragraph, about 200 words.

- Other homework will be posted (**HW**).
- Late homework will not be accepted (unless it is the result of an officially excused absence).
- Each homework (D, J, and HW) is worth 10 points.

3) Paper (20%) – Due: July 2 (Friday)

- Theme: Current issue debated in Texas
 - (1) Choose one issue that you think we should solve in Texas. Explain why you chose it.
 - (2) Who has social responsibility to solve the issue in Texas? (federal/States/local/companies)? Why? How could individuals in Texas contribute to solve the issue?
 - (3) How could we get involved? Why should we be? (Social and Personal Responsibility)
- At least 3 pages
- Format: Times New Roman, 12 point, double-space, 1-inch margin, [Chicago Manual Style \(CMS\) - Author-Date](#).

4) Exams (15% x 4 = 60%)

- You have four exams.
 - Part 1: Closed-book, multiple choice questions (45 questions * 2 points = 90 points)
 - Part 2: Open-book, short answer questions (2 questions * 5 points = 10 points)

- Format: [Chicago Manual Style \(CMS\) - Author-Date \(AD\)](#)
- Times New Roman
 - 12 point
 - Double-spaced
 - 1-inch margins
 - NO footnotes
 - Microsoft WORD file format (.doc or .docx)
- Minimum requirement: 3 pages (you must write more than 3 pages)
- Include a title page and a [reference page](#)
- When you cite, use a direct or indirect quote, but you can only use ONE direct quote per paper.
- Insert [citations](#)
- Do not use subtitles
- You can use the following sources as citations:
 - Academic journal articles
 - Newspaper articles
 - Data and articles from government websites or research institutes such as Pew Research Center
- You CANNOT use the following sources as citations:
 - Wikipedia
 - Procon.org
 - Any other blogs, non-academic websites
 - Editorial page in newspaper
- You CANNOT use or cite papers you wrote before.

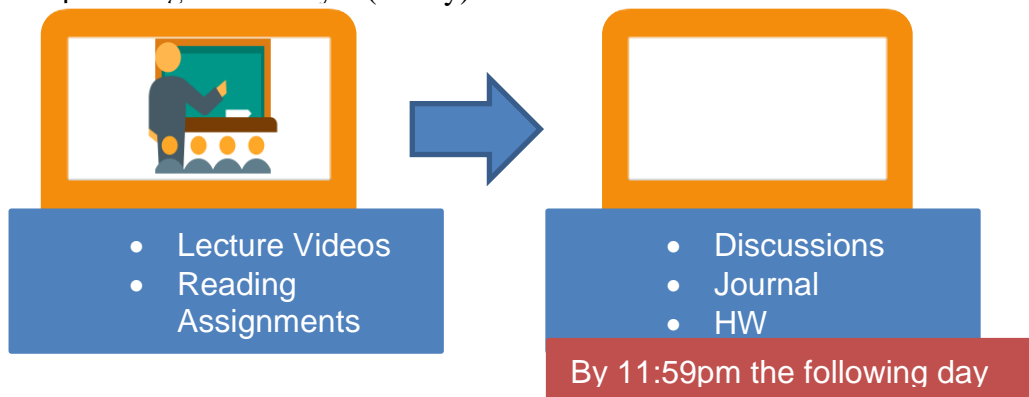
