Required Open Educational Resource (OER) Textbook: *The American Yawp: A Massively Collaborative Open U.S. History Textbook, Vol 1: To 1877.* This is a free open-source textbook, built into the course. Reading assignments are listed on page 9 of the syllabus. Material drawn from the textbook will account for 10% of each exam.

Course Description: A survey of the social, political, economic, cultural, and intellectual history of the United States from the pre-Columbian era to the Civil War/Reconstruction period. United States History I includes the study of pre-Columbian, colonial, revolutionary, early national, slavery and sectionalism, and the Civil War/Reconstruction eras. Themes that may be addressed in United States History I include American settlement and diversity, American culture, religion, civil and human rights, technological change, economic change, immigration and migration, and creation of the federal government.

Determination of Course Grade:

Exams: There will be <u>four exams</u> during the semester with a value of <u>100 points</u> each. Exam material will be drawn from both lectures and assigned readings. Students should pay particular attention to the terms in the study guides. Each exam will consist of **fifty** multiple-choice questions. Each question will be worth **two** points. Make-up exams will be given only under extraordinary circumstances, and all make up exams will have an automatic 10-point penalty assessed. <u>There are no retakes on exams</u>.

Quizzes: In addition to the four exams, there are <u>twenty-five</u> lecture quizzes. Quizzes are in the "Assessments" section of the course. These quizzes consist of two multiple-choice questions on two main points made in each lecture. Each quiz is worth <u>ten</u> points, with each question worth five points. Accordingly, quiz grades will count for a total of 250 points toward the overall course grade. <u>Quizzes not taken by the module deadline will be recorded as zeros and cannot be</u> <u>made up</u>. Do not confuse credit quizzes with the practice quizzes at the end of each lecture. The

practice quizzes at the end of each lecture are not graded and do not count toward your grade. The quizzes in the assessments section of the course count toward your grade. <u>There are no retakes on quizzes</u>.

Textbook Chapter Discussions: There are <u>two</u> textbook chapter discussions. There is a textbook chapter discussion in Modules 1 & 2. <u>There is no textbook chapter discussion for Modules</u> <u>Three and Four.</u> The discussion questions are available in D2L Brightspace at the beginning of each module. After reading the textbook chapter, you will upload a roughly 200-word discussion to the course's D2L Brightspace shell responding to the discussion question. You can turn in the discussion at any time, but it must be turned in on or before that module's deadline. See the course outline section of the course for chapter discussion deadlines. Each discussion posting is worth <u>50</u> points. Chapter discussions will not be accepted past the exam deadline and will be recorded as zeros in the grade book. There are no resubmissions on chapter discussions.

Discussion postings will be evaluated using the following rubric.

- 45 50 points: Contains all required elements
- 40 44 points: Contains most required elements
- 35 39 points: Missing some required elements
- 30 34 points: Missing most required elements
- 29 or less points: Missing all required elements

Oral Presentation Assignment: One of the key core objectives you will develop in college are oral communication skills. To help you develop this skill, this course has an oral communication assignment. The Oral Communication Assignment can be found in the "Assignments" section of the course. You will select any topic from the topics covered in the course and make a five-minute oral presentation on the topic. Students will record their oral presentation on either their cellphone or their computer and then upload the presentation to Brightspace or upload the presentation to YouTube and upload the link to Brightspace. <u>The deadline for the Oral Communication</u> assignment is 11:59 p.m. Saturday, June 14th.

The oral presentation assignment is worth **100 points** and will be graded according to the following rubric:

Paper Assignment: The Paper Assignment can be found in the "Assignments" section of the course. The paper assignment has several objectives that include (1) the student will analyze and interpret primary and secondary sources, (2) create an argument using historical evidence in a <u>two-page paper</u> (double-spaced, 12-point font, Times New Roman), (3) using at least one primary source and at least two secondary sources and finally, (4) the paper assignment will address the

following Core Objectives: Critical Thinking Skills, Communication Skills, Social Responsibility, and Personal Responsibility. Additional details on this assignment are available in Brightspace.

In addition to analyzing and interpreting primary and secondary sources and constructing an argument using historical evidence found in your research, you also <u>MUST</u> include a section in your paper <u>discussing the social and personal responsibility (using the definition on page 7 of the syllabus) of the individual assigned in the assignment.</u> You must discuss these individuals and the issues they were involved in using your <u>critical thinking skills and effectively communicate</u> the personal responsibility and social responsibility of your subject.

The deadline for uploading the paper assignment to Brightspace is <u>11:59 p.m. on Saturday</u>, <u>June 21st</u>. No late papers will be accepted, <u>NO EXCEPTIONS</u>. The paper assignment is worth 100 points. This is a high value assignment. Failure to turn this assignment will adversely affect your final course grade.

The Paper Assignment will be graded using the following rubric:

<u>Choose one of the following individuals as the subject of your Paper</u> <u>Assignment:</u>

Discuss John Brown. Discuss his actions in Kansas and at Harper's Ferry. Include a section on the social and personal responsibility of his actions.

Discuss Eli Whitney. Discuss his invention of the cotton gin. Include a section on the social and personal responsibility of his actions.

Discuss Clara Barton. Discuss her role in the Civil War and in the founding of the American Red Cross. Include a section on the social and personal responsibility of her actions. **Discuss Samuel Morse**. Discuss his contributions toward the development of the telegraph. Also, include a section on his social and personal responsibility, particularly his political views and his views on slavery.

Note: Quality summaries will earn you ten extra points; summaries that are not well done will earn less credit, so don't turn in sloppy work and expect to earn a full ten points extra credit. Summaries must be turned in by the Module Five deadline. Summaries <u>will not</u> be accepted after that date.

Another way to earn extra credit is to select a book from the COM library. Any topic covered in United States history to 1877 is acceptable, but the instructor **must** approve it. After you read the book and write a two-page typed summary of the book, you will receive up to **ten extra credit points**, depending on the quality of the work submitted.

Other extra credit may be offered from time to time at the discretion of the instructor.

Maximum extra credit is <u>thirty</u> points.
